**A RESOLUTION TO AUTHORIZE THE CITY MANAGER TO ENTER INTO A CONTRACT WITH THE FIELD SHOP, IN AN AMOUNT NOT TO EXCEED TWO HUNDRED TWENTY-TWO THOUSAND, EIGHT HUNDRED EIGHTY-FOUR DOLLARS (\$222,884.00), FOR THE PURCHASE OF EQUIPMENT AND SERVICES FOR THE UPGRADE OF THE LITTLE ROCK TELEVISION SYSTEM, CAMERAS, AND STUDIO; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Little Rock issued bid Request for Proposals ("RFP"), Bid No. 15174 for the purchase of equipment and services for the upgrade of the Little Rock Television (LRTV) System; and,

**WHEREAS**, the upgrade will include the replacement of old, outdated LRTV broadcast equipment and replacing it with a new high definition state-of-the-art control room and automation cable channel broadcast system which will allow the Government Access Channel begin transmitting in high definition and provide new live-streaming options; and,

**WHEREAS**, the only bidder for this project was The Field Shop, and the total cost of their proposal is Two Hundred Twenty-Two Thousand, Eight Hundred Eighty-Four Dollars (\$222,884.00), plus taxes and shipping costs; and,

**WHEREAS**, a selection review committee met and determined that The Field Shop met the requirements of the RFP and their bid was responsive and responsible; and,

**WHEREAS**, funding is available from the Little Rock Television Account.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY OF LITTLE ROCK, ARKANSAS:**

**Section 1.** The Board of Directors hereby authorizes the City Manager to enter into a contract with The Field Shop in an amount not to exceed Two Hundred Twenty-Two Thousand, Eight Hundred Eighty-Four Dollars (\$222,884.00), plus taxes and shipping costs, for the purchase of equipment and services for the upgrade of the Little Rock Television System.

**Section 2. Severability.** In the event any title, section, paragraph, item, sentence, clause, phrase, or word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or adjudication shall not affect the remaining portions of the resolution which shall remain in full force and effect as if the portion so declared or adjudged invalid or unconstitutional were not originally a part of the resolution.

1        **Section 3. Repealer.** All laws, ordinances, resolutions, or parts of the same, that are inconsistent with  
2 the provisions of this resolution, are hereby repealed to the extent of such inconsistency.
