LEE STATED HE WAS WALKING AT THE PARK LOCATED AT 11106 BIRCHWOOD DRIVE WITH HIS TWO CHILDREN. LEE STATED HE HAD HEARD A SINGLE SHOT COMING FROM AN UNKNOWN LOCATION AND HE "HIT THE GROUND". LEE LATER ADVISED MAJOR CRIME DETECTIVES HE SAW A GROUP OF MALES PLAYING WITH FIREARMS IN THE PAST NEAR THE HALFWAY HOUSE ON WEST MARKHAM. LEE STATED HE WAS UNAWARE HE WAS SHOT INITIALLY AND WENT TO MEET HIS WIFE AT HIS TRUCK. LEE STATED HE BEGAN TO FEEL A STINGING SENSATION IN HIS CHEST. NARRATIVE

FARAZ STATED THAT WORSHAM THEN THREW AN UNKNOWN AMOUNT OF COINS AT HIM, HITTING HIM IN THE FACE AND CHEST, AND THEN ATTEMPTED TO TAKE THE BEER. FARAZ STATED WORSHAM ATTEMPTED TO TAKE THE BEER EVEN THOUGH THE TRANSACTION WAS NOT COMPLETE. FARAZ WENT TO PULL THE BEER AWAY FROM THE COUNTER, AND WORSHAM HIT HIM IN THE FACE. FARAZ STATED THEY BEGAN TO ARGUE, AND WORSHAM SPIT ON HIM. FARAZ STATED WHILE WORSHAM WAS LEAVING THE STORE, HE TOLD HIM HE WOULD SHOOT HIM. FARAZ STATED HE OBSERVED WORSHAM GO TO HIS VEHICLE, 2007 BLUE FORD FOCUS, AND GRAB AN ITEM FROM THE DRIVER COMPARTMENT. FARAZ BELIEVED THIS TO BE A FIREARM. FARAZ STATED WORSHAM LEFT HIS KEYS IN THE STORE AND LEFT ON FOOT FROM THE LOCATION. OFFICERS CIRCULATED THE AREA AND DETAINED WORSHAM AT 3201 WEST ROOSEVELT. WORSHAM WAS FOUND TO HAVE A SMITH AND WESSON SD40 (SN#FXD4623) ON HIS PERSON. WORSHAM ALSO HAD APPROXIMATELY ONE GRAM OF MARIJUANA ON HIS PERSON. WORSHAM EXCITEDLY UTTERED, WHILE IN CUSTODY, THAT HE DID HIT AND SPIT ON FARAZ.
