14 **Section 2.** Funds for these programs are available in the 2017 Budget for the Community Programs
15 Department.

16 **Section 3.** (a) The term for each contract listed in Section 1 of this resolution shall be for a period of
17 one (1)-year with a start date of January 1, 2017, and an understanding that the City ratifies, accepts, and
18 will compensate any work done between January 1, 2017, and the effective date of this resolution.

19 (b) The City, in its sole discretion and upon mutual agreement of the parties, may extend a contract for
20 a one (1)-year period, not to exceed two (2) additional extensions, one to begin January 1, 2018, and the
21 other to begin Janaury 1, 2019.

22 **Section 4.** All payments are conditioned upon entry into contracts for services that are in a form
23 acceptable to the City Attorney; further, nothing in this resolution prevents the City from being able to offer
24 similar services to any vendor during 2017 if, in its sole discretion, it decides to do so.

25 **Section 5. Severability.** In the event any title, section, paragraph, item, sentence, clause, phrase, or
26 word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or
27 adjudication shall not affect the remaining portions of the resolution which shall remain in full force and
28 effect as if the portion so declared or adjudged invalid or unconstitutional were not originally a part of the
29 resolution.

30 **Section 6. Repealer.** All laws, ordinances, resolutions, or parts of the same, that are inconsistent with
31 the provisions of this resolution, are hereby repealed to the extent of such inconsistency.
