16	WHEREAS, the proposed uses of the City's 2023 Entitlement Funds were developed with extensive		
17	citizen participation, including one (1) public hearing, four (4) public meetings throughout the City and a		
18	seventeen (17)-member Consolidated Planning Committee; and prior to this public hearing, the		
19	Consolidated Planning Committee developed a slate of projects to recommend for Board approval so that		
20	the public hearing will give citizens an additional opportunity to review and comment on the proposed uses		
21	of the 2023 CDBG, HOME and HOPWA Funding; and,		
22	WHEREAS, the Consolidated Planning Committee will submit an allocation of funds as its		
23	recommendation to the Board.
