10	WHEREAS, bids were solicited for the Vimy Ridge Culvert Extension Project, Bid No. 1079; and,
11	WHEREAS, Graylee Construction & Demolition, LLC, was the lowest responsive, responsible bid
12	meeting specifications.
13	NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY
14	OF LITTLE ROCK, ARKANSAS:
15	Section 1. The City Manager is hereby authorized to execute an agreement with Graylee Construction
16	and Demolition for the Vimy Ridge Road Culvert Extension Project, in an amount not to exceed One
17	Hundred Thirty-Four Thousand, Three Hundred Twenty-Six and 43/100 Dollars (\$134,326.43), which is
18	the base bid amount of One Hundred Eleven Thousand, Nine Hundred Thirty-Eight and 70/100 Dollars
19	(\$111,938.70), plus 20% contingencies
20	Section 2. Funding for this project is from a developer contribution under the boundary street ordinance
21	and a Street Fund Special Project for Vimy Ridge Road.
22	Section 3. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, or
23	word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or
24	adjudication shall not affect the remaining portions of the resolution which shall remain in full force and
25	effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the
26	resolution.
27	Section 4. Repealer. All laws, ordinances, resolutions, or parts of the same, that are inconsistent with
28	the provisions of this resolution, are hereby repealed to the extent of such inconsistency.
