6	FOR THE CONSTRUCTION OF JONESBORO DRIVE TRAIL, PHASE 2;
7	AND FOR OTHER PURPOSES.

9	WHEREAS, the City of Little Rock, Arkansas, understands Federal-Aid Transportation Alternatives
10	Program (TAP) Grant Funds are available at 80% Federal participation and 20% local match to develop or
11	improve Jonesboro Road corridor; and,
12	WHEREAS, the City understands that Federal-Aid Funds are available for this project on a
13	reimbursable basis, requiring work to be accomplished and proof of payment prior to actual monetary
14	reimbursement; and,
15	WHEREAS, if the grant is awarded, the project using Federal Funding, will be open and available to
16	for use by the general public and maintained by the applicant for the life of the project.
17	NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY
18	OF LITTLE ROCK, ARKANSAS:
19	Section 1. The City of Little Rock will participate in accordance with its designated responsibility,
20	including maintenance of this project. The Board of Directors pledges its full support and hereby authorizes
21	the City Manager to apply for the grant and the Arkansas Department of Transportation and/or Metroplan
22	to initiate action to implement this project.
23	Section 2. In the event that the grant funds are awarded, the City Manager, or his authorized designee,
24	are hereby authorized and directed to execute all appropriate agreements and contracts necessary to expedite
25	the construction of the above stated project.
26	Section 3. Funding for this project will be from a Metroplan Transportation Alternatives Program
27	Grant and a match from the Street Fund. The maximum grant amount is Two Hundred Thousand
28	Dollars (\$200,000.00), with an estimated City share of Fifty Thousand Dollars (\$50,000.00).
29	Section 4. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, or
30	word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or
31	adjudication shall not affect the remaining portions of the resolution which shall remain in full force and
32	effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the
33	resolution.

Section 5. Repealer. All laws, ordinances, resolutions, or parts of the same, that are inconsisted		
the provisions of this resolution, are hereby repealed to the extent of such inconsistency. ADOPTED: January 4, 2022
