13	WHEREAS appropriate Little Deals Anth. Decalistica No. 9 (66 (March 2, 1002) the City of Little		
14	WHEREAS, pursuant to Little Rock, Ark., Resolution No. 8,666 (March 3, 1992), the City of Little		
15 16	Rock, Arkansas ("the City"), stated its intent to become a part of the Pulaski County Regional Solid		
	Waste Management District ("PCRSWMD"); and, WHEREAS purposent to Little Rook, Ark, Posselution No. 0241 (Morch 7, 1005), the City, and the		
17	WHEREAS, pursuant to Little Rock, Ark., Resolution No. 9341 (March 7, 1995), the City and the		
18 19	PCRSWMD entered into a Curbside Recycling Agreement with Waste Management of Arkansas ("Waste Management"); and,		
20	WHEREAS, pursuant to Little Rock, Ark., Resolution No. 11,497 (April 15, 2003), the City agreed		
21			
22	Curbside Recycling Services; and,		
23	WHEREAS, pursuant to Little Rock, Ark., Resolution No. 13,124 (May 4, 2010), this Recycling		
24	Agreement with Waste Management was extended; and, WHERE AS, purposed to Little Book, Ark, Bookhation No. 12 512 (June 5, 2012), this Books in a		
25	WHEREAS, pursuant to Little Rock, Ark., Resolution No. 13,512 (June 5, 2012), this Recycling Agreement was extended again for a period of seven (7) years until April 1, 2019; and

27	WHEREAS, since this renewal there have been major international changes as to what constitutes		
28	acceptable recycling material, and these changes have led to a significant crash in the market for such		
29	materials, but more to the point, has led to a redefinition of contaminated recycling materials that has		
30	rendered the current agreement economically impractical for Waste Management to fulfill; and,		
31	WHEREAS, after careful consideration and negotiation between the PCRSWMD and Waste Man-		
32	agement it has been determined that with modifications to the existing contract between now and April 1,		
33	2019, and an extension of this contract, then curbside recycling can continue; and,		
34	WHEREAS, the parties mutually desire to extend contract and maintain service thru March 31, 2021;

S	submit this agreement to formal competitive bids.

e	existing Curbside Recycling Contract thru March 3	1, 2021, with Waste Management to provide Curbside		
F	Recycling for approximately 59,000 solid waste customers, at a cost of:			
	(a) \$4.14 per month per residential custom	er for April 1, 2019, through March 31, 2020; and,		
(b) \$4.29 per month per residential customer for April 1, 2020, through March 21, 2021.				
Section 3. Funding for the project is allocated in the Solid Waste Collections Contracts Account No				
6	503110-63390.			
	Section 4. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, or			
word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration o				
г	adjudication shall not affect the remaining portions of the resolution which shall remain in full force and			
e	effect as if the portion so declared or adjudged invalid or unconstitutional were not originally a part of th
