10	WHEREAS, Bids were solicited for improvements to 24 th Street from Walker Street to Vancouver
11	Street, Project No. 16-6-ST-1, Bid No. 18030; and,
12	WHEREAS, Nick Ruffin Excavating, Inc., was the lowest responsive, responsible bid meeting
13	specifications.
14	NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY
15	OF LITTLE ROCK, ARKANSAS:
16	Section 1. The City Manager is hereby authorized to enter into a contract with Nick Ruffin Excavating,
17	Inc., for 24th Street Improvements from Walker Street to Vancouver Street, in an amount not to exceed Five
18	Hundred Seventy-Six Thousand, Three Hundred Twenty-Six and 40/100 dollars (\$576,326.40), which is
19	the base bid amount of Four Hundred Eighty Thousand, Two Hundred Seventy-Two Dollars (\$480,272.00),
20	plus 20% contingencies.
21	Section 2. Funding for this project is from the 3/8-Cent Capital Improvement Sales and Compensating
22	Use Tax Funds as authorized by Resolution No. 14,310.
23	Section 3. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, or
24	word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or
25	adjudication shall not affect the remaining portions of the resolution which shall remain in full force and
26	effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the
27	resolution.
28	Section 4. Repealer. All laws, ordinances, resolutions, or parts of the same, that are inconsistent with
29	the provisions of this resolution, are hereby repealed to the extent of such inconsistency.
