10	Section 1. That the zone classification of the following property be and is hereby changed as indicated:	
11	Z-9450 – Described as part of the S ½ of Section 5, Township 1 South, Range 13 West,	
12	Little Rock, Pulaski County, Arkansas, more particularly described as follows:	
13	Commencing at the northwest comer of Lot 1, Otter Creek Plaza, an addition to the	
14	City of Little Rock, Arkansas, said corner lying on the east right-of-way line of	
15	Arkansas State Hwy. No. 5, (Stagecoach Road); thence northerly along said east right-	
16	of-way line the following: (1) North 15 degrees 35 minutes 51 seconds East, 238.00	
17	feet; (2) North 22 degrees 22 minutes 09 seconds East, 104.40 feet; (3) North 24	
18	degrees 01 minutes 58 seconds East, 148.95 feet; (4) North 88 degrees 43 minutes 00	
19	seconds West, 10.87 feet and North 23 degrees 43 minutes 05 seconds East 192.01 feet	
20	to the point of beginning; thence North 24 degrees 28 minutes 39 seconds east

and designate the change provided for in Section 1 hereof.
