	Section 1. The City Manager is authorized to enter into an agreement with Delta Dental for Group
	Dental Insurance for the period of January 1, 2021, to December 31, 2021, for an amount not to exceed Six
	Hundred Fifty Thousand Dollars (\$650.000.00), which will allow an increase of 100 new city employees
	in 2021.
	Section 2. Funds for this agreement will be available from a line item for Group Dental Insurance in
	the 2021 Budget.
	Section 3. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, or
	word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or
	adjudication shall not affect the remaining portions of the resolution which shall remain in full force and
	effect as if the portion so declared or adjudged invalid or unconstitutional were not originally a part of the
	resolution.
	Section 4. Repealer. All laws, ordinances, resolutions, or parts of the same, that are inconsistent with
	the provisions of this resolution, are hereby repealed to the extent of such inconsistency.
