10	WHEREAS, Bids were solicited for the Chenal Boulevard Traffic Island Modifications, Project No.
11	5-17-ST-225B, Bid No. 972; and,
12	WHEREAS, Redstone Construction Group, Inc., was the lowest responsive, responsible bid meeting
13	specifications.
14	NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY
15	OF LITTLE ROCK, ARKANSAS:
16	Section 1. The City Manager is hereby authorized to execute an agreement with Redstone Construction
17	Group, Inc., for the Chenal Traffic Island Modifications in an amount not to exceed One Hundred Ninety
18	Thousand, Two Hundred Thirty-Four and 62/100 Dollars (\$190,234.62), which is the base bid amount of
19	One Hundred Fifty-Eight Thousand, Five Hundred Twenty-Eight and 85/100 Dollars (\$158,528.85), plus
20	20% contingencies.
21	Section 2. Funding for this project is from the 3/8-Cent Capital Improvement Sales and Compensating
22	Use Tax Funds and the Limited Tax General Obligation Capital Improvement Bonds as authorized by
23	Resolution No. 14,803.
24	Section 3. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, or
25	word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or
26	adjudication shall not affect the remaining portions of the resolution which shall remain in full force and
27	effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the
28	resolution.
29	Section 4. Repealer. All laws, ordinances, resolutions, or parts of the same, that are inconsistent with
30	the provisions of this resolution, are hereby repealed to the extent of such inconsistency.
