12	Tub Grinder to replace an older unit that has caused excessive maintenance costs and down-time; and,

14	050119-VRM; and,
15	WHEREAS, the total cost for the purchase is One Million, Three Hundred Ninety Thousand, Forty-
16	Three and 95/100 Dollars (\$1,390,043.95), plus applicable taxes and fees;
17	NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY

19	Section 1. The City Manager is authorized to enter into an agreement with Vermeer Midsouth, in an
20	amount not to exceed One Million, Three Hundred Ninety Thousand, Forty-Three and 95/100 Dollars
21	(\$1,390,043.95) plus applicable taxes and fees, for the purchase of purchase one (1) TG7000 Tub Grinder
22	to be used by the Public Works Department Landfill Division.
23	Section 2. Funds for this purchase are allocated in the American Rescue Plan Act, Account No.
24	271409-72200-G0601AR40A.
25	Section 3. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, or
26	word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or
27	adjudication shall not affect the remaining portions of the resolution which shall remain in full force and
28	effect as if the portion so declared or adjudged invalid or unconstitutional were not originally a part of the
29	resolution.

31	the provisions of this resolution, are hereby repealed to the extent of such inconsistency.
