SYNOPSIS FISCAL IMPACT	A resolution to approve the submission of the Amended 2020 Annual Action Plan and Amended 2016-2020 Consolidated Plan to the Department of Housing and Urban Development to include CDBG-CV3 supplemental allocation of \$1,016,477, and to authorize the City Manager to enter into contracts for Community Development Block Grant (CDBG) Funding with identified organizations for a period of one (1)-year. The City's CDBG, HOME, and HOPWA Entitlement Funds, along with projected program income for the 2020 Program Year total was \$3,340,511.62 and was approved at the February 18, 2020, Board of Directors Meeting (Resolution No. 15,170).
