12	WHEREAS, the City is often required to perform work on private property that is not in compliance
13	with City Code provisions, or that has deteriorated to an unsafe and vacant condition and must be
14	demolished, because the property owners will not assure that the property is in compliance; and,
15	WHEREAS, Arkansas Code § 14-54-904 et. seq. permits the City to place a lien on the property for
16	the cost of such work and demolitions; and,
17	WHEREAS, at least ten (10) days prior to this meeting, the Housing & Neighborhood Programs
18	Department sent notice to each listed property owner that a hearing would be held this date to determine
19	the accuracy of such lien (Exhibit B); and,
20	WHEREAS, on a total of 158 properties the City wishes to certify Five Hundred Seventy-Nine
21	Thousand, Six Hundred Eighty-Eight and 28/100 Dollars (\$579,688.28) for collection by the Pulaski
22	County Treasurer; and,
23	WHEREAS, no evidence was provided at the public hearing to justify the removal of such lien; and
24	WHEREAS, this certification need to be made before December 1, 2018.
25	NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY
26	OF LITTLE ROCK, ARKANSAS:
27	Section 1. The Board of Directors authorizes the certification of the liens listed on Exhibit A to this
28	resolution to the Pulaski County Treasurer to be collected as part of the Annual Property Tax Bill for the
29	involved properties.
30	Section 2. The Board held a public hearing on November 20, 2018, to let effected property owners
31	challenge the amount of any lien that was placed by the City on their individual parcels.
32	Section 3. The Board expressly notes that prior to this public hearing written notice similar to the
33	form of the letter attached as Exhibit B to this resolution was sent to each property owner sent for each lien
34	to each property owner at least thirty (30) days prior to the public hearing on November 20, 2018.
