11	BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE CITY OF LITTLE			
12	ROCK, ARKANSAS.

14	SECTION 1. That the zoning classification of the following described property be			
15	changed from Revised PD-C, Planned Development Commercial to Revised PD-C, Planned			
16	Development Commercial:

18	Z-7701-D - Part of Block 17, Sach's Suburban Tracts, Little Rock,			
19	Pulaski County, Arkansas, more particularly described as: Commencing			
20	at the southeast corner of said Block 17; thence west along the south line			
21	of said Block 17, 34.30 feet; thence north 5.0 feet to the point of			
22	beginning; thence west 146.18 feet; thence N33°35'58"E			
23	335.52 feet to a point on the south right of way line of Kanis Road; thence			
24	S56°02'21"E along the south right of way line of Kanis Road 120.06 feet;			
25	thence S33°56'16"W 15.06 feet; thence N56°0344"E			
26	348.75 feet to the point of beginning containing 1.75 acres more or less.

28	SECTION 2. That the preliminary site development plan/plat be approved as			
29	recommended by the Little Rock Planning Commission.

6	SECTION 4.	That the map referred to in Chapter 36 of the Code of Ordinances of			
7	the City of Little Rock, A	Arkansas, and designated district map be and is hereby amended to the			
8	extent and in the respects necessary to affect and designate the change provided for in Section				
9	1 hereof.

11	SECTION 5.	That this Ordinance shall not take effect and be in full force until the			
12	final approval of the plan.

14	SECTION 6.	Severability. In the event any title, section, paragraph, item,			
15	sentence, clause, phrase, or word of this ordinance is declared or adjudged to be invalid or				
16	unconstitutional, such declaration or adjudication shall not affect the remaining portions of the				
17	ordinance which shall remain in full force and effect as if the portion so declared or adjudged				
18	invalid or unconstitutional was not originally a part of the ordinance.

20	SECTION 7.	Repealer. All laws, ordinances, resolutions, or parts of the same			
21	that are inconsistent with	n the provisions of this ordinance are hereby repealed to the extent of			
22	such inconsistency.
