17 **Section 2.** The City of Little Rock shall provide Police and Fire protection; assume maintenance
18 responsibility for the portion of Baker Lane fronting said property; and allow the PCSSD to connect to the
19 Little Rock Waste Water System from the effective date of the annexation. Since PCSSD has an existing
20 wastewater system in place to service all three Joe T Robinson Schools, the City of Little Rock shall allow
21 that connection to continue when it is connected to the City system even though the Joe T Robinson
22 Elementary School will not be annexed to the City.

23 **Section 3. Severability.** In the event any title, section, paragraph, item, sentence, clause, phrase, or
24 word of this ordinance is declared or adjudged to be invalid or unconstitutional, such declaration or
25 adjudication shall not affect the remaining portions of the ordinance which shall remain in full force and
26 effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the
27 ordinance.

28 **Section 4. Repealer.** All ordinances or resolutions of the City in conflict herewith are hereby repealed
29 to the extent of such conflict.
