10	WHEREAS, the City provides certain Group Vision Insurance Benefits for its employees, and after a			
11				
12	to provide such insurance for current City employees is VSP; and,			
13	WHEREAS, the basic cost of such coverage to the City will not exceed One Hundred Thirty-Five			
14	Thousand Dollars (\$135,000.00) and will allow for an additional 100 new employees in 2020.			
15	NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY			
16	OF LITTLE ROCK, ARKANSAS:			
17	Section 1. The City Manager is authorized to enter into a renewal agreement with VSP for Group			
18	Vision Insurance for the period of January 1, 2020, to December 31, 2020, in an amount not to exceed One			
19	Hundred Thirty-Five Thousand Dollars (\$135,000.00), which will provide coverage to existing employees			
20	of the City and allow for an increase of 100 new employees in 2020. This represents year four (4) of the			
21	seven (7)-year term.			
22	Section 2. Funds for this contract extension will be available from a line item for Group Vision			
23	Insurance in the 2020 Budget.			
24	Section 3. Pursuant to approval by the City, this contract may be extended three (3) additional times			
25	of the maximum seven (7) year term in accordance with the renewal clause in the agreement.			
26	Section 4. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, or			
27	word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or			
28	adjudication shall not affect the remaining portions of the resolution which shall remain in full force and			
29	effect as if the portion so declared or adjudged invalid or unconstitutional were not originally a part of the			
30	resolution.			
31	Section 5. Repealer. All laws, ordinances, resolutions, or parts of the same, that are inconsistent with			
32	the provisions of this resolution, are hereby repealed to the extent of such inconsistency.
