10	WHEREAS, Bids were solicited for construction of the Pecan Lake Area Drainage Improvements
11	Project No. 16-7-DR-141, Bid No. 17023, and,
12	WHEREAS, JCI Construction, Inc., was the lowest responsive, responsible bid meeting specifications.
13	NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY OF
14	LITTLE ROCK, ARKANSAS:
15	Section 1. The City Manager is hereby authorized to execute an agreement with JCI Construction, Inc.,
16	for the Pecan Lake Area Drainage Improvement Project, in an amount not to exceed One Hundred
17	Thirteen Thousand, Seven Hundred Twenty-One and 60/100 Dollars (\$113,721.60), which is the base bid
18	amount of Ninety-Four Thousand, Seven Hundred Sixty-Eight Dollars (\$94,768.00), plus 20%
19	contingencies.
20	Section 2. Funding for this project is from the 3/8-Cent Capital Improvement Sales and Compensating
21	Use Tax Funds and the 2013 Capital Improvement Bonds for Streets and Drainage as authorized by
22	Resolution No. 13,699 and amended by Resolution No. 14,269.
23	Section 3. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, or word
24	of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or
25	adjudication shall not affect the remaining portions of the resolution which shall remain in full force and
26	effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the
27	resolution.
28	Section 4. Repealer. All laws, ordinances, resolutions, or parts of the same, that are inconsistent with the
29	provisions of this resolution, are hereby repealed to the extent of such inconsistency.
