11	Block 8, R. D. Duncan's Addition to the City of Little Rock, Pulaski County,		
12	Arkansas.

14	A part of the SW 1/4 of the SW 1/4 of Section 35, T-2-N, R-13-W, City of Little Rock,		
15	Pulaski County, Arkansas. being more particularly described as follows:		
16	Commencing at the NE corner of said SW 1/4, SW 1/4; thence N87°23'13" West, 31.75		
17	feet to the Point of Beginning; thence S43°54'12" West, 41.03 feet; thence S25°11'34"

34	and designate the change provided for in Section 1 hereof.

5	ordinance.

7	the provisions of this ordinance are hereby repealed to the extent of such inconsistency.
