- **Section 3.** The name of the Improvement District shall be City of Little Rock Municipal Property Owners' Multi-Purpose Improvement District 2023-002 (Edgewood Subdivision Recreation District).
- **Section 4.** *Severability*. The various parts, sections and clauses of this ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by court of competent jurisdiction, the remainder of this ordinance shall not be affected thereby.
- Section 5. *Repealer*. All laws, ordinances, resolutions, or parts thereof in conflict with the provision of this ordinance are hereby repealed to the extent of such conflict.

1	Section 6. <i>Emergency Clause.</i> The Board of Directors of the City of Little Rock, Arkansas, ha		
2	determined that with development in the area covered by the boundaries of the Improvement District laid		
3	off in this ordinance requires, as critical to the public health, safety, and welfare, construction of additional		
4	infrastructure; an emergency is, therefore, declared to exist, and this ordinance shall be in full force and		
5	effect from and after the date of its passage.
