16	Section 4. That this ordinance shall not take effect and be in full force until the final plan approval.			
17	Section 5. That the map referred to in Chapter 36 of the Code of Ordinances of the City of Little Rock			
18	Arkansas, and Designated District Map be and is hereby amended to the extent and in the respects necessary			
19	to affect and designate the change provided for in Section 1 hereof.			
20	Section 6. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, o			
21	word of this ordinance is declared or adjudged to be invalid or unconstitutional, such declaration o			
22	adjudication shall not affect the remaining portions o	f the ordinance which shall remain in full force and		
23	effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the			
24	ordinance.			
25	Section 7. Repealer. All laws, ordinances, resol	utions, or parts of the same that are inconsistent with		
26	the provisions of this ordinance are hereby repealed to	the provisions of this ordinance are hereby repealed to the extent of such inconsistency.
