| 11 | WHEREAS, the Board of Directors of the City of Little Rock, Arkansas (the "City"), passed Little |
| 12 | Rock, Ark., Ordinance No (April, 2021) which, if approved by the City electors, levies a 1% |
| 13 | Sales and Use Tax within the City; and, |
| 14 | WHEREAS, pursuant to Ark. Code Ann. § 26-75-308 a municipality, on once an ordinance which |
| 15 | levies a Sales and Use Tax is adopted, must, by ordinance provide for the calling and holding of a special |
| 16 | election on the question of whether to approve the levy; and, |
| 17 | WHEREAS, the purpose of this ordinance is to call a special election on the question of the levy of |
| 18 | the Sales and Use Tax. |
| 19 | NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE CITY |
| 20 | OF LITTLE ROCK, ARKANSAS: |
| 21 | Section 1. A special election is also hereby called to be held on July 13, 2021, at which special election |
| 22 | there shall be submitted to the electors of the City the question of the levy of a 1% Sales and Use Tax |
| 23 | pursuant to Little Rock, Ark., Ordinance No (April, 2021), and which shall start collection on |
| 24 | January 1, 2022, and shall be levied on the receipts from the sale at retail of all items and services that are |
| 25 | subject to taxation under the Arkansas Gross Receipts Tax Act of 1941, as amended, as set out in Title 26, |
| 26 | Chapter 52, and the Arkansas Compensating Use Tax of 1949, as amended, as set out in Title 26, Chapter |
| 27 | 53. |
| 28 | Section 2. On the ballot at the special election on the question referred to in Section 3 of this ordinance |
| 29 | the question of whether to levy a Sales and Compensating Use Tax referred to above in substantially the |
| 30 | following form: |

1 Section 9. Severability. In the event any section, subsection, subdivision, paragraph, subparagraph, 2 item, sentence, clause, phrase, or word of this ordinance is declared or adjudged to be invalid or 3 unconstitutional, such declaration or adjudication shall not affect the remaining provisions of this 4 ordinance, as if such invalid or unconstitutional provision was not originally a part of this ordinance.

5 Section 10. Repealer. All ordinances, resolutions, bylaws, and other matters inconsistent with this ordinance, including but not limited to Little Rock, Ark., Ordinance No. 20,449 (July 11, 2011) and, Little 6 7 Rock, Ark., Ordinance No. 20,450 (July 11, 2011), are hereby repealed to the extent of such inconsistency.

8 Section 11. Emergency Clause. The ability to properly fund necessary improvements, programs, 9 and operations of the City, and to properly budget for them as part of the process to adopt a 2022 Annual 10 Budget, and to have a timely election on the question of whether to impose the additional sales and 11 compensating use tax levy called for in this ordinance is essential to the public health, safety, and welfare; 12 an emergency is, therefore, declared to exist and this ordinance shall be in full force and effect from and

13 after the date of its passage and publication.
