25	Section 6. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, or	
26	word of this ordinance is declared or adjudged to be invalid or unconstitutional, such declaration or	
27	adjudication shall not affect the remaining portions of the ordinance which shall remain in full force an	
28	effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of th	
29	ordinance.

31	provisions of this ordinance are hereby repealed to the extent of such inconsistency.
