10	WHEREAS, in Little Rock, Ark., Resolution No. 15,170 (February 18, 2020), the Board of Directors		
11	approved the sources and uses of 2020 Community Development Block Grant Funds from the United States		
12	Department of Housing & Urban Development (HUD); and,		
13	WHEREAS, in Little Rock, Ark., Resolution No. 15,211 (April 28, 2020), the Board of Directors		
14	approved additional sources and uses of 2020 Community Development Block Grant Coronavirus		
15	("CDBG-CV") Funds from HUD; and,		
16	WHEREAS, the Urban League was to receive One Hundred Thousand Dollars (\$100,000.00) of the		
17	2020 CDBG-CV for public service activities; and,		
18	WHEREAS, the Urban League failed to enter into an agreement with the City of Little Rock to expend		
19	said funds; and,		
20	WHEREAS, it is necessary to reallocate the CDBG-CV Funds which the Board of Directors approved		
21	for the Urban League from a public service activity to the Central Arkansas Development Council for rental		
22	assistance; and,		
23	WHEREAS, this reallocation of funds will not change the total 2020 Budget of the CDBG-CV Funds		
24	which is One Million, Eight Hundred Ninety-Five Thousand, Five Hindered Twenty-Six Dollars		
25	(\$1,895,526.00).		
26	NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY		
27	OF LITTLE ROCK, ARKANSAS:		
28	Section 1. One Hundred Thousand Dollars (\$100,000.00) of the 2020 Community Development Block		
29	Grant Coronavirus Funds from the United States Department of Housing & Urban Development, monitored		
30	by the Housing & Neighborhood Programs Department, shall be reallocated from the Urban League from		
31	a public service activity to the Central Arkansas Development Council for rental assistance.		
32	Section 2. The City Manager is hereby authorized to enter into a contract with the Central Arkansas		
33	Development Council in an amount not to exceed One Hundred Thousand Dollars (\$100,000.00).		

1	word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration

3	adjudication shall not affect the remaining portions of the resolution which shall remain in full force and		
4	effect as if the portion so declared or adjudged invalid or unconstitutional were not originally a part of the

7	the provisions of this resolution, are hereby repealed to the extent of such inconsistency.
