FISCAL IMPACT	The City is expected to receive \$2,895,809.00 in 2021 CDBG, HOME, and HOPWA Funds from the United States Department of Housing and Urban Development (HUD). Funds in the amount of \$306,908.17, 2021 program income and \$40,000.00 reallocated funds will be added to the entitlements thereby making the total expected amount \$3,242,717.17.
