10	Section 1. That the zone classification of the following property be and is hereby changed as indicated:		
11	Z-9562: Described as part of Lot 2, Southland Acres, Little Rock, Pulaski County,

13	County, Arkansas, more particularly described as follows: Commencing at the		
14	southwest corner of said Lot 2, thence North 03 degrees 23 minutes 57 seconds East		
15	300.98 feet to the Point of Beginning; thence North 03 degrees 23 minutes 57 seconds		
16	East 405.75 feet to the Northwest corner of Lot 2; thence South 84 degrees 42 minutes		
17	28 seconds East 297.75 feet to the northeast corner of Lot 2; thence South 03 degrees		
18	50 minutes 04 seconds West 433.85 feet to the north right-of-way of Baseline Road;		
19	thence continue along said north right-of-way North 85 degrees 33 minutes 03 seconds		
20	West 157.70 feet; thence leaving said north right-of-way North 03 degrees 43 minutes

28	Section 3. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, or		
29	word of this ordinance is declared or adjudged to be invalid or unconstitutional, such declaration of		
30	adjudication shall not affect the remaining portions of the ordinance which shall remain in full force and		
31	effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the		
32	ordinance.		
33	Section 4. Repealer. All laws, ordinances, resolutions, or parts of the same that are inconsistent with		

the provisions of this ordinance are hereby repealed to the extent of such inconsistency.
