12	Section 1. That the zoning classification of the following described property be changed from PCD		
13	Planned Commercial District, to Revised PCD, Planned Commercial District:		
14	<b>Z-7870-A</b> : DESCRIBED AS PART OF THE NW1/4 SW1/4 OF SECTION 8, T-2-N,		
15	R-14-W, PULASKI COUNTY, ARKANSAS, BEING MORE PARTICULARLY		
16	DESCRIBED AS FOLLOWS: COMMENCING AT THE NORTHEAST CORNER		
17	OF THE SAID NW1/4 SW1/4 OF SECTION 8; THENCE N87°19'15"W, A		
18	DISTANCE OF 163.07 FEET TO THE POINT OF BEGINNING; THENCE		
19	S01°43'04"W, A DISTANCE OF 384.99 FEET; THENCE N55°24'54"W, A		
20	DISTANCE OF 144.40 FEET; S47°22'18"W, A DISTANCE OF 98.14 OF FEET;		
21	THENCE S31°30'48"W, A DISTANCE 59.44 FEET TO A POINT ON THE NORTH		
22	RIGHT OF WAY LINE OF AR STATE HIGHWAY 10; THENCE N55° 33'00"W		
23	ALONG SAID NORTH RIGHT OF WAY, A DISTANCE OF 124.45 FEET;		
24	THENCE N01°51'40"E, A DISTANCE OF 365.68 FEET; THENCE S87°11'42"E, A		
25	DISTANCE OF 324.83 FEET TO THE POINT OF BEGINNING, CONTAINING		
26	2.75 ACRES, MORE OR LESS.		
27	Section 2. That the preliminary site development plan/plat be approved as presented to the Little Rock		
28	Planning Commission.		
29	Section 3. That the change in zoning classification contemplated for King Seasonal Fireworks Sales		
30	Revised PCD, located at 23800 Highway 10 (Z-7870-A), is conditioned upon obtaining final plan approva		
31	within the time specified by Chapter 36, Article VII, Section 36-454 (e) of the Code of Ordinances.		
32	Section 4. That this ordinance shall not take effect and be in full force until the final plan approval.		

1	<b>Section 5.</b> That the map referred to in Chapter 36 of the Code of Ordinances of the City of Little Rock,		
2	Arkansas, and Designated District Map be and is hereby amended to the extent and in the respects necessary		
3	to affect and designate the change provided for in Section 1 hereof.		
4	Section 6. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, or		
5	word of this ordinance is declared or adjudged to be invalid or unconstitutional, such declaration or		
6	adjudication shall not affect the remaining portions of the ordinance which shall remain in full force and		
7	effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the		
8	ordinance.		
9	Section 7. Repealer. All laws, ordinances, resolutions, or parts of the same that are inconsistent with		
10	the provisions of this ordinance are hereby repealed to the extent of such inconsistency.
