3	NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY

5	SECTION 1. The City Manager is hereby authorized to execute an agreement with JCI
6	Construction, Inc., for drainage improvements along Overlook Drive in an amount not to exceed Two
7	Hundred Thousand, Four Hundred Forty and 80/100 Dollars (\$200,440.80), which is the base bid amount
8	of One Hundred Sixty-Seven Thousand, Thirty-Four Dollars (\$167,034.00), plus 20% contingencies.
9	SECTION 2. Funding for this project is from the 3/8-Cent Capital Improvement Sales and
20	Compensating Use Tax Funds as authorized by Resolution No. 13,699.
21	SECTION 3. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase,
22	or word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or
3	adjudication shall not affect the remaining portions of the resolution which shall remain in full force and
.4	effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the
