9	WHEREAS, Bids were solicited for the for Little Rock Bike Connector (Arkansas Highway and
10	Transportation Department #061422), Bid Number 15-002; and,
11	WHEREAS, Township Builders, Inc., was the lowest responsive, responsible bid meeting
12	specifications.
13	NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY
14	OF LITTLE ROCK, ARKANSAS:
15	SECTION 1. The City Manager is hereby authorized to execute an agreement with Township
16	Builders, Inc., for the Little Rock Bike Connector in an amount not to exceed Nine Hundred Fifty-Eigh
17	Thousand, Two Hundred Eighty-Seven Dollars (\$958,287.00), which is the base bid amount of Seven
18	Hundred Ninety-Eight Thousand, Five Hundred Seventy-Two and 50/100 Dollars (\$798,572.50), plus
19	20% contingencies.
20	SECTION 2. Funding for this project is from Transportation Alternatives Grant Funds, (80% o
21	eligible costs) designated grant match funds and State Tax Turn-Back in Street Fund.
22	SECTION 3. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase
23	or word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration o
24	adjudication shall not affect the remaining portions of the resolution which shall remain in full force and
25	effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the
26	resolution.
27	SECTION 4. Repealer. All laws, ordinances, resolutions, or parts of the same, that are inconsisten
28	with the provisions of this resolution, are hereby repealed to the extent of such inconsistency.
29	<b>SECTION 5.</b> This resolution will be in full force and effect from and after the date of its adoption.
