11	WHEREAS, the City Board of Directors determined the creation of a Temporary Entertainment		
12	District as proposed by Ordinance No. 21,761 as amended is appropriate as recommended by the Planning		
13	& Development Department; and,		
14	WHEREAS, the City Board of Directors adopted in Resolution 15,375 (January 19, 2021), the		
15	Hillcrest Entertainment District as a Temporary Entertainment District providing days and hours of		
16	operation to be February 4, 2021, and March 4, 2021, from 4:00 PM to 9:00 PM; and,		
17	WHEREAS, the City Board of Directors adopted in Resolution 15,416 (March 16, 2021), the Hillcrest		
18	Entertainment District as a Temporary Entertainment District providing days and hours of operation to		
19	begin on April 1, 2021, and end June 3, 2021, providing days and hours of operation to be April 1, 2021,		
20	from 4:00 PM to 9:00 PM; May 6, 2021, from 4:00 PM until 9:00 PM; and June 3, 2021, from 4:00 PM		
21	until 9:00 PM;		
22	WHEREAS, the City of Little Rock has received an application to extend the Temporary		
23	Entertainment District for three (3) days beginning on August 5, 2021, from 4:00 PM - 9:00 PM;		
24	September 2, 2021, from 4:00 PM - 9:00 PM; and October 7, 2021, from 4:00 PM - 9:00 PM. The City		
25	reserves the right to amend boundaries and hours of operation at its sole discretion.		
26	NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY		
27	OF LITTLE ROCK, ARKANSAS.		
28	Section 1. The Hillcrest Entertainment District is hereby extended by the City of Little Rock as a		
29	Temporary Entertainment District on July 6, 2021, and subject to Ordinance No. 21,761, as amended and		
30	its defined terms.		
31	Section 2. Boundaries. The boundaries of the Hillcrest Entertainment District are North Monroe		
32	Street, east to Walnut Street; Beechwood Street, between Kavanaugh Boulevard and Woodlawn Drive, and		
33	North Palm Street, between Reechwood Street and F Street

2	Entertainment District upon the adoption of this resolution and shall expire on October 7, 2021. The dates			
3	and times are August 5, 2021, from $4:00\ PM-9:00\ PM$ ; September 2, 2021, from $4:00\ PM-9:00\ PM$ ; and			
4	October 7, 2021, from 4:00 PM - 9:00 PM. The City reserves the right to amend boundaries and hours of			
5	operation at its sole discretion.			
6	Section 4. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, or			
7	word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or			
8	adjudication shall not affect the remaining portions of the resolution which shall remain in full force and			
9	effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the			
10	resolution.			
11	Section 5. Repealer. All laws, ordinances, resolutions, or parts of the same, that are inconsistent with			
12	the provisions of this resolution, are hereby repealed to the extent of such inconsistency.
