10	WHEREAS, Galls, LLC, submitted a combined bid response providing Official Price Sheets to bid
11	Event No. 304, and is also an approved vendor through the State Contract No. 4600033832; and,
12	WHEREAS, staff recommends that a contract be awarded to Galls, LLC, in an amount not to exceed
13	Two Hundred Fifty Thousand Dollars (\$250,000.00), for the purchase of Police Uniforms and Uniform
14	Accessories.
15	NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY
16	OF LITTLE ROCK, ARKANSAS:
17	Section 1. The City Manager is authorized to enter into a one (1)-year contract with Galls, LLC, with
18	two (2) additional one (1)-year renewal term options, for the purchase of Police Uniforms and Uniform
19	Accessories in annual amount not to exceed of Two Hundred Fifty Thousand Dollars (\$250,000.00).
20	Section 2. Funding for this purchase is available from the Little Rock Police Department General
21	Funds Account No. 105220-60050.
22	Section 3. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, or
23	word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or
24	adjudication shall not affect the remaining portions of the resolution which shall remain in full force and
25	effect as if the portion so declared or adjudged invalid or unconstitutional were not originally a part of the
26	resolution.
27	Section 4. Repealer. All laws, ordinances, resolutions, or parts of the same, that are inconsistent with
28	the provisions of this resolution, are hereby repealed to the extent of such inconsistency.
