10	BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE CITY OF LITTLE ROCK,	
11	ARKANSAS.	
12	SECTION 1. That the zoning classification of the following described property be changed from R-	
13	2, Single-Family District, to PD-R, Planned Development - Residential:	
14	Z-9038 : Lots 6 and 7 Block 6 Hillcrest Addition to the City of Little Rock, Pulaski County,	
15	Arkansas, and the eastern 12.5 feet of the former right-of-way for North Spruce Street	
16	abandoned by the City of Little Rock as a public right-of-way by the adoption of Ordinance	
17	No. 19,394.	
18	SECTION 2. That the preliminary site development plan/plat be approved as recommended by the	
19	Little Rock Planning Commission.	
20	SECTION 3. That the change in zoning classification contemplated for Metzger Short-Form PD-R	
21	(Z-9038), located at 4723 North Lookout Road, is conditioned upon obtaining a final plan approval within	
22	the time specified by Chapter 36, Article VII, Section 36-454 (e) of the Code of Ordinances.	
23	SECTION 4. That the map referred to in Chapter 36 of the Code of Ordinances of the City of Little	
24	Rock, Arkansas, and designated district map be and is hereby amended to the extent and in the respects	
25	necessary to affect and designate the change provided for in Section 1 hereof.	
26	SECTION 5. That this ordinance shall not take effect and be in full force until the final approval of	
27	the plan.	
28	SECTION 6. Severability. In the event any title, section, paragraph, item, sentence, clause,	
29	phrase, or word of this ordinance is declared or adjudged to be invalid or unconstitutional, such declaration	
30	or adjudication shall not affect the remaining portions of the ordinance which shall remain in full force and	
31	effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the	
32	ordinance.
