10	WHEREAS, Bids were solicited for drainage improvements along Florida Avenue at L and M
11	Streets, Project Number 13-3-018, Bid Number 15-010.; and,
12	WHEREAS, Burkhalter Technologies, Inc., was the lowest responsive, responsible bid meeting
13	specifications.
14	NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY
15	OF LITTLE ROCK, ARKANSAS:
16	SECTION 1. The City Manager is hereby authorized to execute an agreement for Burkhalter
17	Technologies, Inc., for the Florida Avenue Improvement Project in an amount not to exceed Ninety-Six
18	Thousand, Four Hundred Fifty-five and 90/100 Dollars (\$96,455.90), which is the base bid amount of
19	Eighty Thousand, Three Hundred Seventy-Nine and 92/100 Dollars (\$80,379.92), plus 20%
20	contingencies.
21	SECTION 2. Funding for this project is from the 3/8-Cent Capital Improvement Sales Tax and
22	Compensating Use Tax Funds as authorized by Resolution No. 13,699.
23	<b>SECTION 3.</b> Severability. In the event any title, section, paragraph, item, sentence, clause, phrase,
24	or word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or
25	adjudication shall not affect the remaining portions of the resolution which shall remain in full force and
26	effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the
27	resolution.
28	<b>SECTION 4.</b> <i>Repealer.</i> All laws, ordinances, resolutions, or parts of the same, that are inconsistent
29	with the provisions of this resolution, are hereby repealed to the extent of such inconsistency.
30	<b>SECTION 5.</b> This resolution will be in full force and effect from and after the date of its adoption.
