#### Abstract

A RESOLUTION TO AUTHORIZE THE CITY MANAGER TO ENTER INTO A CONTRACT WITH MUSCO SPORTS LIGHTING, LLC, IN AN AMOUNT NOT TO EXCEED EIGHT HUNDRED SEVENTY-FIVE THOUSAND DOLLARS $(\$ 875,000.00)$, PLUS APPLICABLE TA XES AND FEES, FOR NEW FACILITY SPORT LIGHTS FOR SIX (6) B ASEB ALL/SOFTB ALL FIELDS AT THE JUNIOR DEPUTY BASEBALL PARK; AND FOR OTHER PURPOSES.


WHEREAS, the City of Little Rock, Arkansas ("the City"), is the owner of the property upon which baseball fields and other fixtures are in place for a youth program that includes, among other things, a Youth Baseball Program ("Junior Deputy Baseball Park"); and,

WHEREAS, improved lighting has been desired by Junior Deputy Baseball Park users for many years to provide a higher quality and equal field light standard; and,

WHEREAS, new lights at Junior Deputy Baseball Park will remove ongoing existing maintenance costs, lower ongoing utility cost, and meet the general sustainability goals; and,

WHEREAS, on December 20, 2022, the City of Little Rock Board of Directors adopted Resolution No. 15,847 to express its intent that, under the American Rescue Plan Act ("ARPA") category of Expenditure of Lost Revenue on Governmental Services, funds from the second tranche of the ARPA Funds be prioritized and expended for certain listed government services, which included Capital Improvements at City-Owned Baseball Fields located at 2500 Cantrell Road, also known as Junior Deputy Baseball Park, in the amount of Eight Hundred Seventy-Five Thousand Dollars (\$875,000.00); and,

WHEREAS, Musco Lighting, LLC, is a light-structure system with total light control - TLC for LED Technology which provides a guaranteed light level, improved luminaire efficiency, increased durability, and an innovative monitoring service that enables scheduling and control of lights remotely; and,

WHEREAS, the Cooperative Purchasing Agreement with Sourcewell Master Project No: 199030, Contract No. 071619-MSL will be utilized for procurement, at a cost not-to-exceed Eight Hundred Seventy-Five Thousand Dollars ( $\$ 875,000.00$ ), plus applic able taxes and fees.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY OF LITTLE ROCK, ARKANSAS:

Section 1. The City Manager is authorized to enter into a contract with Musco Sports Lighting, LLC, in an amount not-to-exceed Eight Hundred Seventy-Five Thousand Dollars (\$875,000.00), for new facility sport lights for six (6) baseball/softball fields at the Junior Deputy Baseball Park.

Section 2. Funds for this contract are available in Account No. 271459-G0601AR45B-72799 JUNIOR DEPUTY.

Section 3. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, or word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or adjudication shall not affect the remaining portions of the resolution which shall remain in full force and effect as if the portion so declared or adjudged invalid or unconstitutional were not originally a part of the resolution.

Section 4. Repealer. All laws, ordinances, resolutions, or parts of the same, that are inconsistent with the provisions of this resolution, are hereby repealed to the extent of such inconsistency.
