12	WHEREAS, the Information Technology Department requests authorization to upgrade the City of	
13	Little Rock, Arkansas ("City"), CISCO Network Core Infrastructure to increase Cyber Security	
14	Technology; and,	
15	WHEREAS, the current network infrastructure is fifteen (15) years old and will not allow the inclusion	
16	of Advanced Cyber Security Technology; and,	
17	WHEREAS, the cyber security upgrade will allow Information Technology Staff to add advanced	
18	Cyber Security attributes to assist in the protection of confidential data, provide remote user ease of access,	
19	utilization of monitoring tools for quick identification of cyber threats, multifactor authentication and other	
20	technology needed to protect the City and its users; and,	
21	WHEREAS, vendor selection of Presidio Networked Solutions was made through utilization of the	
22	State Contract No. 4600048977 SP-20-0051; and,	
23	WHEREAS, the total cost for the contract, which will expire on or before December 31, 2026, is not	
24	to exceed Three Million, Three Hundred Ninety-Seven Thousand, Forty-Two Dollars (\$3,397,042.00), plus	
25	applicable taxes and fees, with funding provided by the American Rescue Plan Act.	
26	NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY	
27	OF LITTLE ROCK, ARKANSAS:	
28	Section 1. The City Manager is authorized to enter into a contract with Presidio Networked Solutions	
29	to upgrade the City's CISCO Network Core Infrastructure to increase Cyber Security Technology in the	
30	amount not to exceed Three Million, Three Hundred Ninety-Seven Thousand, Forty-Two Dollars	
31	(\$3,397,042.00), plus applicable taxes and fees, for a contract term expiration date on or before December	
32	31, 2026.	
33 34	Section 2. Funds for this expenditure will be taken from Account No. 271 – American Rescue Plan (APPA)	
34	(ARPA).	

1	Section 3. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, or		
2	word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or		
3	adjudication shall not affect the remaining portions of the resolution which shall remain in full force and		
4	effect as if the portion so declared or adjudged invalid or unconstitutional were not originally a part of the		
5	resolution.

7	the provisions of this resolution, are hereby repealed to the extent of such inconsistency.
