#### Abstract

AN ORDINANCE TO APPROVED A PLANNED ZONING DEVELOPMENT AND ESTABLISH A PLANNED RESIDENTIAL DISTRICT TITLED HERRICK HEIGHTS LONG-FORM PD-R, LOCATED ON THE WEST SIDE OF SOUTH BOWMAN ROAD, BETWEEN BRODIE CREEK SUBDIVISION AND THE POINTE AT BRODIE CREEK APARTMENTS (Z-8503-D), LITTLE ROCK, ARKANSAS, AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF LITTLE ROCK, ARKANSAS; AND FOR OTHER PURPOSES.


BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE CITY OF LITTLE ROCK, ARKANSAS.

Section 1. That the zoning classification of the following described property be changed from R-2, Single-Family District, to PD-R, Planned Development - Residential:

# AND THE ADJACENT FLOODWAY FOR BRODIE CREEK AS SHOWN ON FIRM PANEL 05119C0431G DATED JULY 6, 2015, DESCRIBED AS THE FLOODWAY ACROSS BLOCKS 2, 3, 6, \& 8 HERRICK HEIGHTS, AN ADDITION TO PULASKI COUNTY, ARKANSAS LESS AND EXCEPT LOT 4, BLOCK 3 OF SAID HERRICK HEIGHTS ADDITION, CONTAINING APPROXIMATELY 4.9 ACRES, MORE OR LESS. 

Section 2. That the preliminary site development plan/plat be approved as recommended by the Little Rock Planning Commission including the following additional conditions:

1. Construct a single-lane roundabout or traffic signal at the intersection of South Bowman Road and Brodie Creek Trail, including landscape and restoration of landscape within the right-ofway provided when warranted, and when the need is met as determined by the City with the various phases of the proposed apartment development. If the need for the improvement has not been met by the final phase of the proposed apartment development the developer will place the cost of the improvement with the City in the form of an in-lieu payment and allow the funds to remain with the City for a period of five (5) years from the date of completion of the final phase of the proposed apartment development. If a traffic signal is constructed the constructed signal improvements consist of necessary poles, foundations, mast arms, signal heads, pedestrian poles and heads for pedestrians crossings as needed, conduits, wiring, cabinet, controller, radio, video equipment, electrical service connection and all incidental work related there to. Provide a fifty (50)-foot wide buffer along the northern boundary of the PRD, Planned Residential Development. No trees are to be removed from the buffer, but additional plant materials may be added as part of an approved Landscape Plan. That portion of the PRD marked "Proposed Residential" will be developed as single-family residential, with lots widths and home sizes similar to those in either the Brodie Creek and/or Woodlands Edge developments.
Section 3. That the change in zoning classification contemplated for Herrick Heights Long-Form PDR, located on the west side of South Bowman Road between Brodie Creek Subdivision and the Pointe at Brodie Creek Apartments (Z-8503-D), is conditioned upon obtaining final plan approval within the time specified by Chapter 36, Article VII, Section 36-454 (e) of the Code of Ordinances.

Section 4. That this ordinance shall not take effect and be in full force until the final plan approval.
Section 5. That the map referred to in Chapter 36 of the Code of Ordinances of the City of Little Rock, Arkansas, and designated district map be and is hereby amended to the extent and in the respects necessary to affect and designate the change provided for in Section 1 hereof.
