3 **A RESOLUTION TO AUTHORIZE THE CITY MANAGER TO ENTER**
4 **INTO A CONTRACT WITH BOYLES CONSTRUCTION, INC., IN AN**
5 **AMOUNT NOT TO EXCEED ONE MILLION, FIVE HUNDRED FOUR**
6 **THOUSAND, ONE HUNDRED EIGHTY-SEVEN AND 14/100 DOLLARS**
7 **(\$1,504,187.14), FOR IMPROVEMENTS TO KANIS ROAD FROM**
8 **BOWMAN ROAD TO AUTUMN ROAD, AND FOR OTHER PURPOSES.**

10 **WHEREAS**, Bids were solicited for improvements to Kanis Road from Bowman Road to Autumn
11 Road, Project No. 13-B-5D-6A, Bid Event No. 547; and,

12 **WHEREAS**, Boyles Construction, Inc., was the lowest responsive, responsible bid meeting
13 specifications.

14 **NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY**
15 **OF LITTLE ROCK, ARKANSAS:**

16 **Section 1.** The City Manager is hereby authorized to execute an agreement with Boyles Construction,
17 Inc., for improvements to Kanis Road from Bowman Road to Autumn Road in an amount not to exceed
18 One Million, Five Hundred Four Thousand, One Hundred Eighty-Seven and 14/100 Dollars
19 (\$1,504,187.14), which is the base bid amount of One Million, Two Hundred Fifty-Three Thousand, Four
20 Hundred Eighty-Nine and 28/100 Dollars (\$1,253,489.28), plus 20% contingencies..

21 **Section 2.** Funding for this project is from the ⅓-Cent Capital Improvement Sales and Compensating
22 Use Tax Funds and the 2018 Capital Improvement Bonds for Streets and Drainage as authorized by
23 Resolution No. 14,803 (June 19, 2018).

24 **Section 3. *Severability.*** In the event any title, section, paragraph, item, sentence, clause, phrase, or
25 word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or
26 adjudication shall not affect the remaining portions of the resolution which shall remain in full force and
27 effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the
28 resolution.

29 **Section 4. *Repealer.*** All laws, ordinances, resolutions, or parts of the same, that are inconsistent with
30 the provisions of this resolution, are hereby repealed to the extent of such inconsistency.
