9	WHEREAS, a Petition to form City of Little Rock Municipal Property Owners' Multipurpose		
10	Improvement District No. No. 2022-004 (Woodland Park Recreation District) has been filed with the Little		
11	Rock City Clerk; and,		
12	WHEREAS, the City Clerk has presented the petition to the Mayor; and,		
13	WHEREAS, the Mayor has set September 20, 2022 at 6:00 PM or as soon afterwards as the item may

15	Board of Directors for consideration of the Petition; and,		
16	WHEREAS, the Little Rock Board of Directors has determined from an Abstractor's Certificate of		
17	Property Ownership that those signing the petition constitute all the owners of the real property to be located		
18	in said District; and,		
19	WHEREAS, the City Clerk has presented proof of notice of this hearing in the manner prescribed by

29	Section 1. The real property described as:

31	WEST 1/2 OF TRACT 16 AND 2.30 ACRES BEING A PART OF TRACT 10 AND		
32	TRACT 14 OF ASBURY ACRES RECREATION DISTRICT, BEING MORE		
33	PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCING AT THE

16 is hereby establish as City of Little Rock, Arkansas Municipal Property Owners' Multipurpose 17 Improvement District No. 2022-004 (Woodland Park Recreation District) for the purposes of purchasing, 18 accepting as a gift, constructing, or maintaining facilities for the purpose of providing recreational facilities 19 and maintaining the infrastructure and improvements within the District, together with facilities, related to 20 any of the foregoing or for more than one (1) of those purposes, whether within or outside the boundaries 21 for the Proposed District; doing all things now or hereafter permitted under applicable law, including 22 limitation, A.C.A. §14-94-110, to be done and performed by Municipal Property Owners' Improvement 23 Districts. The purposes are to be accomplished in the manner and with the materials that the Commissioners 24 for the District shall deem in the best interest of the District and as specified by law. The cost of the project 25 of the District shall be assessed upon the real property of the District according to the benefits received. 26 Section 2. The following three (3) individuals nominated in the petition, are hereby appointed as 27 Commissioners of said Improvement District: Scott Hurley; Randy James; and Graham Smith. 28 Section 3. The name of the improvement District shall be Woodland Park Recreation District 29 Municipal Property Owners' Multi-Purpose Improvement District No.2022-004 of Little Rock, Arkansas.

30 Section 4. *Severability*. The various parts, sections and clauses of this ordinance are hereby declared 31 to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid 32 by court of competent jurisdiction, the remainder of this ordinance shall not be affected thereby.

33 Section 5. *Repealer*. All laws, ordinances, resolutions, or parts thereof in conflict with the provision
34 of this ordinance are hereby repealed to the extent of such conflict.

1	Section 6. Emergency Clause. The Board of Directors of the City of Little Rock, Arkansas, has		
2	determined that with development in the area covered by the boundaries of the Improvement District laid		
3	off in this ordinance requires, as critical to the public health, safety, and welfare, construction of additional		
4	infrastructure; an emergency is, therefore, declared to exist, and this ordinance shall be in full force and		
5	effect from and after the date of its passage.
