


The Major Crimes Division consists of five investigative units: Homicide; Robbery; Violent Crimes; Juvenile; and Financial Crimes Units. The Division, also, has a Victim Services Unit that is responsible for providing information and referral services to victims of violent crimes. Also included within this division is the Crime Scene Search Unit, which provides crime scene search and photographic services, as well as latent print examination, to all of the Department's divisions.

HOMICIDE UNIT

In 2016, the Homicide Unit investigated 39 criminal homicides and 3 homicides which are non-criminal, pending file review. This is an increase over the previous year of 35.48%. There is not a definitive reason for this increase. Overall, the Homicide Unit worked 512 cases including death and suicide investigations. The Homicide Unit holds a clearance rate of 59.54% for 2016.









Robbery Unit

The Robbery Unit investigated 134 aggravated business robberies in 2016, and cleared 53 by arrest for a 40% clearance rate. Included in those figures are 4 bank robberies, which were all cleared by arrest. They also investigated 54 shoplifting robberies and cleared 23 by arrest for a 43% clearance rate.




JUVENILE CRIMES UNIT

The Juvenile Crimes Unit is committed to working with other agencies to build partnerships and improve the efficiency of our investigations for the citizens of Little Rock. The Juvenile Crimes Unit has formed a partnership with other surrounding agencies to form a Child Abduction Response Team. This partnership can access resources from other agencies to help manage a successful investigation.



FINANCIAL UNIT

In 2016, the Financial Crimes Unit worked 967 cases. Of these cases that were assigned, 175 were cleared by arrest. There are also currently 35 cases that were assigned in 2016 that have active warrants to be cleared upon arrest. The Financial Crimes Unit has successfully worked with the U.S. Postal Inspector's Office as well as the U.S. Attorney's Office in obtaining federal indictments for some of our largest mail theft and forgery suspects. This includes a thirteen count indictment of one individual for various financial crimes. The Unit also recovered one firearm during an arrest.





VICTIM SERVICES PROGRAM

The Victim Services Program provides information and referrals to persons who have been a victim of violent crime in the City of Little Rock. Victim Services assists victims with referrals to service providers, information on the criminal justice system, obtaining an Order of Protection and other services that may be necessary as a result of the crime. There are currently three staff members of the Victim Services Program. In 2016, the Victim Services Program has served 3,096 victims and provided them with 8,545 services.

CRIME SCENE SEARCH UNIT

The Crime Scene Search Unit (CSSU) of the Little Rock Police Department processed a total of 1,203 crime scenes in the year 2016. Although the unit is located in the Major Crimes Division, which consists of the Homicide, Robbery, Violent Crimes, Financial Crimes & Juvenile Units, it also supports the Property Crimes and Patrol Units in all three precincts. The CSSU currently has 9 Crime Scene Specialist. Specialists had a case load average of 200.5 crime scenes per Specialist for the year. The CSSU also has 2 Latent Prints Examiners. There were 17,658 latent prints compared with 1,140 identifications made in 2016.



Duties

The Special Investigations Division is organized and tasked as the primary unit to investigate and suppress organized crime, vice, and narcotics related offenses. The Division's activities are designed to support the actions of the other divisions within the Department. The Division is organized under the Investigative Bureau. The Division is also tasked with being the primary liaison between the Little Rock Police Department and our federal law enforcement partners.

Narcotics Unit

The **Narcotics Unit** is responsible for the investigation of criminal offenses related to the trafficking of controlled substances. In 2016, the Narcotics Section engaged in investigations to positively impact the illegal narcotics trafficking in Little Rock and to support the goals of other departmental units in the reduction of city-wide crime. These investigations resulted in multiple arrests and the removal of large quantities of narcotics from our city.

During 2016, the Narcotics Section arrested 982 individuals and charged them with 1,965 felonies and 1,317 misdemeanor crimes. The unit (including task force officers) seized 963.2 kilograms of marijuana, 114.0 kilograms of methamphetamine, 38.6 kilograms of cocaine, 23.8 kilograms of heroin, 20,215 diverted pharmaceutical pills and 273 firearms. In addition, the division seized in excess of 1.3 million dollars in illegal proceeds during narcotic investigations.

The Narcotics Unit is comprised of the Street Narcotics Squad and the Narcotics Interdiction Squad. The Street Narcotics Squad is tasked with disrupting street level narcotics activity. The Narcotics Interdiction Squad is tasked with disrupting the flow of narcotics shipments within the City of Little Rock. The Narcotics Interdiction Squad utilizes two specially trained K9s. The Narcotics Unit has Task Force Officers assigned to the Drug Enforcement Agency and the Federal Bureau of Investigations

Vice/Intelligence Unit

The Vice/Intel Unit is comprised of the Intelligence Squad and the Vice Squad. These two specialty squads provide significant support to the other divisions within the Department.

The **Intelligence Squad** is responsible for the investigation into criminal activity, organized or otherwise, the coordination and assistance to Federal agencies for dignitary visits to Little Rock, and other investigations as assigned by the Office of the Chief of Police. During 2016, the unit assisted on ten dignitary visits and worked many hours assisting other divisional and departmental units with investigations utilizing specialized technical equipment. The unit is also responsible for the installation and maintenance of the City's Crime Camera System. During 2016 the Intelligence Squad (including Task Force Officers) seized ninety-six firearms, and almost \$3,300,000 in cash and assets. The squad arrested 370 individuals, who were charged with 627 felonies and 408 misdemeanors. The Intelligence Squad has Task Force Officers assigned to the Federal Bureau of Investigations, Internal Revenue Service, and the Bureau of Alcohol, Tobacco, and Firearms.

The **Vice Squad** is responsible for the investigation of criminal offenses involving prostitution, pornography, gambling, and liquor violation to include the investigation of all assigned Alcohol Beverage Control permit applications in Little Rock. During 2016, the unit processed 90 ABC permit applications, and arrested 376 individuals resulting in 948 felony charges and 778 misdemeanor charges. The Vice Squad also conducted 40 investigations into Internet Crimes Against Children and human trafficking, and seized 46 illegal gambling machines The Vice Squad has one detective assigned to the Internet Crimes Against Children Task Force.

Duties

The Little Rock Police Department's Special Operations Division mission focuses on working with people directly to solve problems and to build relationships within the communities they serve. While patrolling on foot, motorcycles, or in patrol cars; we will work together with the community on efforts targeted at preventing physical and social decay, disorder, and fear of crime, in order to improve the overall quality of life in our communities, schools and neighborhoods.

The Special Operations Division is under the command of Captain Tanya Washington, and reports to the Field Services Bureau Chief. The Division is comprised of thirteen (13) specialized units, to include: Airport, Aviation, Canine (K-9), Crisis Negotiation Unit (CNU), Hit-N-Run, Honor Guard, MOTORS, School Resource Officer, Special Events, (SRO), Special Response Unit (SRU), SWAT, and Youth Programs.

Airport Unit

The Airport Unit is located at the Bill and Hillary Clinton National Airport, which is located at #1 Airport Road. The Airport Unit consists of three Sergeants, thirteen officers, and two civilian Traffic Wardens. The Airport Unit also has an Explosives Detection Team (EDT) contingent, consisting of a sergeant, two officers, and three explosive detection trained canines.

The Airport Unit is responsible for enforcing all federal, state, and local criminal/traffic laws, in and around the airport terminal and on airport property. The Airport Unit works in conjunction with the Department of Homeland Security, FBI, and TSA to ensure the safety of the airport. During the 2016 year, the Airport Unit made the following accomplishments and completed the following tasks:

- On April 5, 2016, the LRPD Airport Unit took part in an Airport Emergency Exercise which simulated a crashed and on fire commercial jet aircraft. The real time scenario included casualties and fatalities to be dealt with. There were over two hundred participants from city, county, state, and federal agencies.
- During 2016 the LRPD Airport Unit arrested twenty-two passengers and seized twenty-two firearms. The passengers attempted to pass through the TSA Screening Checkpoint and board flights with the firearms of various makes, calibers, and sizes in their carryon luggage.
- On April 6, 2016 the Explosive Detection Teams along with other LRPD Airport Unit personnel participated in a CBRA/IED Exercise scenario in which the EDT's were tasked in locating explosive devices placed in various secured and unsecured areas of the airport and apprehending the suspect (s) who placed them in the airport. During 2016 the Explosive Canine Teams brought a new canine on board

Aviation Unit

The Aviation Unit is staffed by 3 part-time helicopter pilots, 2 part-time civilian observers and 6 part-time sworn-officer observers. Accomplishments for this year include the successful sell of one helicopter, and the hiring of two (2) additional current fleet at two (2) helicopters.

Hit & Run/Special Events

The Little Rock Police Department's Hit and Run/Special Events Unit is currently staffed with two (2) officers and one (1) Sergeant. The unit is assigned Hit and Run Accidents across the entire City of Little Rock. Each officer investigates approximately 250 cases per month.

In 2016 the Hit and Run Office investigated 2998 cases. Of those cases, the unit was able to clear 1268 cases by arrests. This comes to a clearance rate of 42%; the national average for Hit and Run clearance is 32%.

In addition to the duties of Hit and Run accidents, the two hit and run officers handle all permitted events, which come to the unit from the City of Little Rock's Traffic Engineers Office. The officers meet with the promoters and sponsors of events to ensure that the events are handled within the guidelines set forth in the permits. If off-duty Little Rock officers are needed to facilitate these events, i.e. traffic and event security, the unit is responsible for ensuring that adequate staffing of personnel is deployed. This Unit works closely with the United States Secret Service in assisting with Dignitary escorts and security. They also manage the twenty-five (25) Little Rock School Crossing Guard positions, which includes the posting of vacant positions, hiring, training, placement and equipment issue.

This Office was also instrumental in the planning, logistics and deployment of personnel in the following Major events in the City of Little Rock:

- Martin Luther King Marade
- Little Rock Marathon
- Riverfest
- Arkansas State Fair
- Razorback Football games



Honor Guard

The Little Rock Police Department's Honor Guard Unit is comprised of one (1) lieutenant and twenty-six (26) officers. One of the primary duties of a ceremonial honor guard unit is escorting a fallen hero/officer to a final resting place; it is considered one of the highest forms of respect offered by an honor guard unit. The unit participated in fifteen (15) funeral processions of retired police officers throughout the 2016 year.

In addition to assisting with funerals, the unit participated in the following activities in 2016:

- Little Rock Police Officer's Memorial
- State of Arkansas Law Enforcement Memorial
- Color Guard/Honorary Escort for the 9/11 Honor Flag
- Color Guards for the Justice Department's VRN Conference held in Little Rock
- Color Guard for Pankey Community Center grand opening



K-9 Unit

The K-9 unit is comprised of eight (8) canine teams. Each team consists of a K-9 handler and a dual-purpose trained K-9. Each team undergoes weekly specialized training in order to ensure their effectiveness. All K-9 teams must successfully complete an annual State Certification and National Certification through the National Narcotic Detector Dog Association. The K-9s are trained to conduct building and large area searches for hidden criminals, track/trail criminals, article/evidence searches and illegal narcotics detection. The K-9s are also featured at numerous community education functions and public demonstrations. The K-9 Unit plays a vital role in providing support for law enforcement units such as field services, SWAT, and criminal





The K-9 Unit (2016):

- Responded to 5,498 calls for service
- Participated in 2,544 hours of training/school
- Participated in 22 public demonstrations
- Conducted 693 narcotic sniffs
- Conducted 108 building searches
- Conducted 89 area searches
- Made 393 criminal arrests
- Recovered 92.5 lbs. of marijuana

Motorcycle Unit


The Motorcycle Unit has an authorized staffing of one (1) sergeant and nine (9) officers. The Motors Unit has twelve (12) Harley Davidson motorcycles in its inventory, along with three (3) RU2 Fast 850/870 Radar Speed Display Trailers. The speed radar trailers are deployed throughout the city on a recurring basis, generally in response to citizens' requests or traffic complaints received from citizens, or the City Board of Directors. The speed radar trailers are also deployed in school zones as a deterrent to speeding, and in other areas of the City for the purpose of traffic control or conducting traffic analysis.

During the 2016 year, the speed radar trailer was deployed at thirty-nine (39) different locations around the city and was used for twelve (12) different traffic studies. The Motorcycle Unit received 106 traffic complaints from citizens and twelve (12) traffic complaints through the City Board of Directors office. All complaints were responded to in a timely manner with officers working recurring traffic assignments in the area of the complaint to reduce the number of traffic violations alleviating the traffic complaint.

In addition to working traffic assignments related to citizen and Board of Director complaints, the unit accomplished the following:

- Deployed speed radar trailers in thirty-nine (39) different locations
- Worked recurring traffic assignments at more than ninety (90) different locations
- Conducted parking enforcement on business parking lots and in various neighborhoods
- Issued a total of 4,386 citations
 - 3,506 moving violations and 158 parking violations
 - Speeding was the primary moving violation with a total of 3,267 counts.
- Made 86 misdemeanor/felony criminal arrests and made 89 misdemeanor/felony warrant arrest
- Worked fourteen (14) 5K races, twelve (12) funerals and six (6) parades.





START Unit

Strategic Accident Reduction Team

The S.T.A.R.T. Unit responds to, and investigates collisions involving fatalities and life-threatening injuries within the city limits of Little Rock. They are also responsible for DWI enforcement, traffic enforcement, working special events, instructing at the LRPD Training Academy, and assisting with the prosecution of collision-related misdemeanor and felony, negligent homicide cases.

On June 25, 2016, the S.T.A.R.T. Unit was absorbed back into the patrol divisions to supplement manpower needs. For the remainder of the year, the only traffic-related duty the unit performed was responding to traffic collision reconstructions when called upon. Due to this reorganization, the S.T.A.R.T. Unit only has traffic numbers through the month of June, 2016.

Through June of 2016, the S.T.A.R.T. Unit:

- Made 1,829 Traffic Arrests
- Issued 508 Speeding Tickets
- Made 70 DWI Arrests
- Issued 205 Warning Citations
- Issued 231 Non-Hazardous Citation
- Conducted the LRPD's 2nd Safety Sobriety Checkpoint

In addition to traffic and DWI Enforcement, the S.T.A.R.T. Unit was tasked with instructing recruit classes in the areas of Standardized Field Sobriety Testing and Traffic Accident Investigations. In 2016, S.T.A.R.T. Officers logged over 500 hours of instruction time including both recruit schools and officer in-service classes. Also, in 2016, S.T.A.R.T. Officers responded to 26 traffic reconstruction call-outs, which included 16 collisions resulting in the loss of a life. Officers respond to the scene and conduct independent investigations until they are either closed without charges, or until the case is prosecuted in a court.

On Nov. 4, 2016, along with 22 other officers of varying ranks, the S.T.A.R.T. Unit completed the department's second Safety Sobriety Checkpoint. The checkpoint was completed successfully and without incident,

Safety Sobriety Checkpoint

SWAT Unit

The Special Weapons and Tactical (SWAT) Unit is staffed by a Lieutenant (Unit Commander), two (2) sergeants (Team Leaders), and twenty-five (25) officers. All personnel participate in tactical training three days per month, maintain monthly qualifications on all firearms, and must pass a quarterly physical fitness test. Counter terrorism training and joint training with the Crisis Negotiations Team and other agency tactical teams are included in the annual training matrix.

The primary mission of the Special Weapons and Tactics Unit is to provide support to the Department during operations that require special training and equipment to resolve high-risk situations. These operations include, but are not limited to, barricaded subjects, hostage incidents, high-risk warrant service, and dignitary protection. In 2016, the unit responded to **seven (7) SWAT call-outs** and executed **eighty-nine (89) high-risk search warrants.** The Unit is supported in training and operations by tactical paramedics from the MEMS STAR Team



Crisis Negotiation Unit

During the 2016 year, the Crisis Negotiation Unit (CNU) responded to seven (7) call outs, and had five (5) training dates last year.

Accomplished the following:

- Joint training with the Pulaski County Sherriff Office and the L.R.P.D. SWAT team.
- Acquired the old Communications van for call outs, and the van is in the process of being renovated.
- The CNU discussed training for 2017. The CNU will continue doing yearly training with the Little Rock Police SWAT team, and hopefully joint training with surrounding agencies.
- The CNU is also in the process of getting the team Nationally Certified.

School Resource Unit

The Little Rock Police Department's School Resource Unit is currently staffed with eighteen (18) officers and two (2) sergeants. The officers are assigned to five (5) high schools, seven (7) middle schools, and one (1) Alternative Learning Center. The objectives of the School Resource Unit is to promote and assist the Little Rock School District in providing a safe learning environment, and to improve relationships between Law Enforcement Officers and today's youth. During the course of the 2016 school year, the SRO's conducted classroom presentations, teaching various topics, throughout the year, to include the following:

Smarter Choices Better Chances Bullying Police & You Drug Education Conflict Resolution Sexting/Video Voyeurism Traffic/Criminal Juvenile Law Texting & Driving

In addition to the classroom presentation some of the SRO's continued to counsel and assist students on various activities within the school system and outside the school system.:

- Officer Allen took several of his at risk students at Hamilton to the DMV and assist them with getting Identification cards, and later rewarded them by taking them to lunch.
- Officer LeQuana Brown created an all-girls mentor group at her school, Hall High, called "Girl Talk." She hosted a Christmas party for the girls at McMath Library.
- Officer Yolanda Bone created a Food Drive, at Cloverdale Middle School, to help the flood victims in Louisiana. She collected multiple boxes of food, toiletries and assorted clothing.
- Numerous SRO's assisted the Parks & Recreation Department with their Annual Fishing Derby, hosted at McArthur Park.
- Officer Calvin Allen and Officer Crystal Simmons helped deliver donated Christmas gifts to needy families, within the City of Little Rock.

One of the SRO's most significant achievements for the 2016 school year, was Officer Calvin Allen receiving the "SRO of the Year" award, for the State of Arkansas.







Special Response Unit

The Special Response Unit is made up of (2) lieutenants, (5) sergeants, and (33) officers that are split up into four squads:

- Shield Team 1
- Shield Team 2
- Weapons/Arrest/Cut Team
- Weapons/Arrest Team

The Unit is responsible for responding to all civil disobedience actions against the City of Little Rock. During the year 2016, the unit was involved in cross-training with the N.L.R.P.D., Arkansas National Guard, and the Arkansas State Police. This training was conducted primarily to establish a means of determining a State of Operational Readiness within each Department.

The Special Response Unit also acquired two large buses, from the Law Enforcement Support Office (LESO) Program in 2016. The buses are used to transport the unit to special events and incidents requiring their assistance. The Special Response Unit responded to several events during the 2016 calendar year including two (2) protests, which resulted in eight (8) arrests. The "Fight for \$15" was the other protest that the SRU unit attended in Little Rock. This particular protest was also held nation-wide.



Youth Programs

The L.R.P.D. Youth Programs consists of the Boys O.K. (Our Kids) Program and the Girls G.E.M.S. (Girls Empowered By Mentoring Sisterhood) Program. The Youth Programs Unit is comprised of one (1) sergeant and two (2) officers.

O.K. Program

There are currently 192 male students enrolled in the O.K. Program. There are two (2) high schools and three (3)

middle schools that partner with the program throughout the year; Henderson Middle School was added on as a partner for the 2015-2016 school year. There are currently 16 OK Alumni students attending colleges and universities in the State of Arkansas; three of those students are scheduled to graduate this year. There were four (4) reward trips

awarded to students of the OK Program who maintained a 2.5 grade point average or above this year.

Youth Programs

G.E.M.\$. Program

The Little Rock Police Department implemented a Girls program, "G.E.M.S." (Girls Empowered by Mentoring Sisterhood), During the 2015-2016 school year. The program is designed to assist and mentor school-age girls in the Little Rock School District. There is one (1) high school and two (2) middle schools that partner with the program throughout the year. The GEMS Program currently has 30 adult female mentors and 144 female students signed up for the program. The program's average weekly participation is 25-30 girls each Saturday.

Students in the G.E.M.S. Program participated in four (4) community service projects to include:

The **Training Division** is responsible for the training of all sworn officers, recruits, and civilian personnel of the Little Rock Police Department. This includes 40-hours of annual In-Service training, specific to the needs of the service area, which includes: Deadly Force Training, Procedural Justice, De-escalation, Domestic Violence, Legal Updates, Firearms Proficiency, and Realistic Scenario-based Training. The Training Division works with state, federal and surrounding law enforcement agencies to ensure up-to-date training, reflective of best practices established by the President's Task Force on 21st Century Policing.

The Division administers a comprehensive basic academy training program for police recruits in compliance with the Commission on Law Enforcement Standards and Training (CLEST). In addition, the Division recruits applicants for entry level Police Officer and Certified Officer positions. Assigned personnel also assist the City of Little Rock Human Resources Department with applicant interviews, testing and background investigations for all sworn and civilian applicants.

The Training Division is comprised of four (4) units; The Administrative/Records Unit, In-Service Unit, Recruit Training Unit, and the Police Recruitment Unit.



The Administrative/Records Unit is staffed by two (2) civilian employees who are responsible for maintaining all official records related to all training received by Department personnel sworn and civilian, as well as submitting curriculum to the Arkansas Commission on Law Enforcement Standards and Training (CLEST). This unit is also tasked with guiding the Training Academy through international accreditation under the auspice of the Commission on Accreditation for Law Enforcement Agencies, Inc. (CALEA). The Administrative Unit works under the CLEST state regulations for the hiring and initial certification of all police officers.

The In-Service Unit is currently comprised of one (1) Sergeant and three (3) Officers. During the 2016 fiscal year, the In-Service Unit was busy conducting or hosting internal and external training, annual firearms qualifications, inventory monitoring and firearms maintenance. The Unit conducted over 1,293 hours of training and hosted over 210 hours of classes/seminars.

Encouraging partnerships with other agencies remained a priority for the In-Service Unit. During this past year, the Arkansas Tactical Officers Association, Arkansas State Police, Department of Veteran's Affairs Police Department, Attorney General's Office, Pulaski County Sheriff's Office, Arkansas Children's Hospital Security, University of Arkansas Medical Sciences Police Department, U.S. Attorney's Office, U.S. Customs and LR Zoo Special Response Team utilized the Department's range and/or classrooms for training.

The In-Service Unit facilitated rapid response exercises with the Little Rock Fire Department, and the Metropolitan Emergency Medical Service (MEMS). The purpose of such training prepares officers and other first responders to effectively respond in the event of an active shooter or mass casualty event.



In light of recent incidents around the country, it is crucial to public safety that Little Rock Police Department officers work closely with other emergency personnel, schools, businesses and the community to create safe workplaces. The Unit provided Civilian Response to Active Shooter Events (CRASE) training to the following organizations, businesses and schools: Verizon, Little Rock School District, City of Little Rock, Little Rock Metropolitan Vo-tech, Arkansas Department of Education, Arkansas School for the Deaf, Arkansas Electric Co-op, Central Arkansas Library, Heifer International, Little Rock Zoo and numerous local churches. The Unit worked closely with the Arkansas Attorney General's Office and the Arkansas Law Enforcement Training Academy instructing Active Aggressor Response to sworn personnel statewide.



Staff continued to issue medical trauma kits to personnel in 2016. The medical trauma kit is compact and contains items essential for the treatment of life threatening injuries encountered by law enforcement. These kits may save an officer's life, their partner's life or the life of someone in the community.

The In-Service Unit worked with various groups from the Mental Health Community to develop instruction in De-escalation communication techniques that were presented to all sworn personnel as part of the 2016 In-Service training sessions.

This past year, the Unit was fortunate enough to receive funding for the renovation of our small arms firing range, which had not been updated in the past two decades. This modernization project will help address range performance issues and provide the opportunity for more reality based training. Improvements are scheduled to be completed in early 2017.




The Recruit Training Unit is responsible for the daily operations of basic recruit training, which includes the coordination and implementation of the knowledge and skills required to provide successful law enforcement. Recruits are assigned to a 24-week Basic Training Academy class. While assigned to the Academy, new recruits learn to make the transition from civilians to police officers through intense academic and dynamic training techniques.

During 2016, the Recruit Training Unit conducted two (2) basic academies, trained 38 entry-level police recruits and five (5) recruits from other agencies (Little Rock Fire Department and North Little Rock Police Department). Each recruit was provided with 960 hours of basic instruction.







Health and Substance Abuse Programs as well as organizations, such as, the Alzheimer's Association and Autism Association and others.

The **Police Recruitment Unit** is responsible for recruiting a diverse group of qualified applicants for the position of police officer/recruit. To achieve this effort, partnerships have been formed with local media outlets, church groups, private recruiting companies, local high schools and university organizations. The Police Recruitment Unit consists of one (1) Sergeant and four (4) Officers.



The Unit successfully conducted 1,245 preliminary background investigations of entry-level applicants, resulting in 83 background investigation files to be considered for Basic Recruit Class #85. The Unit was also responsible for conducting 248 preliminary background investigations on applicants for civilian positions within the Department.



The Police Recruitment Unit has established several local business contacts to develop productive recruitment relationships such as, a professional partnership with Metropolitan Vocational School and Job Corps to allow individuals to bridge the gap between law enforcement and high school age students. Attendance at church functions to establish better relations with civilians and bolster their confidence in the Department and promoting minority candidates interest in law enforcement.

A continued working relationship with the Little Rock Air Force Base strives to recruit servicemen and women exiting the military as a potential pool of applicants. The Unit will pursue other opportunities to recruit a diverse group of qualified applicants by attending community meetings, use of various social media platforms, visiting college job fairs and special events both inside and outside the state.

The Records and Support Division is comprised of the Records Section, the Technology and Equipment Section, and the Accreditation Unit. The Division is under the direction of a captain who reports directly to the Assistant Chief of Police – Executive Bureau.

Information Technology & Equipment Section

The Information Technology and Equipment Section, is comprised of the crime analysts section, vehicle coordinator section and technology section. The unit is staffed with two sworn officers and nine civilians and is under the command of a Lieutenant. The IT unit is responsible for the compliance of all ACIC/NCIC regulations, all information technology requests involving new computers, cell phones, iPads and vehicle related IT audio/video recording, downloading and storage for the entire department. The vehicle coordinator section is responsible for the maintenance and service of all Departmental vehicles and associated communications equipment.






Crime Analysis

The crime analysis section assists the Command Staff in the coordination of Crime Analysis activities and reporting and serves as a liaison with the Office of Information Technology. The crime analysis section utilizes a systematic process to identify and analyze patterns and trends in crime and disorder and provide information on patterns which help commanders deploy resources in a more effective manner, and assists detectives in identifying and apprehending suspects. This unit also conducts project research analysis and ensures departmental compliance with appropriate criminal statistics reporting protocol, as well as supervises the maintenance and upgrading of the computerized police records management systems.



Accreditation Unit

The Accreditation Unit is under the direction of a Sergeant and is responsible for the management and distribution of departmental directives, coordinates and assists in announced and unannounced inspections of all Departmental components to ensure compliance with all standards mandated by the Commission on Accreditation for Law Enforcement Agencies, Inc. (CALEA). The unit ensures that all CALEA compliance files are up-to-date, serves as a liaison to CALEA for all accreditation matters, and provides assistance to all departmental units, by providing clarification and ensuring compliance with CALEA standards. Additionally, the Unit maintains and assists the executive staff in the research, development, and preparation of new and/or revised Departmental orders and forms, new programs, policy and procedures or acquisition of equipment to improve the performance of the Department. The Unit also serves as a management tool to the Chief of Police by conducting comprehensive review and analysis of Departmental operations, procedures, personnel and facilities.



In 2016, the Little Rock Police Department was awarded Reaccreditation with Excellence (Gold Standard), the seventh consecutive reaccreditation the Department has received. The Gold Standard Accreditation demonstrates the Department's continuous commitment to meeting and exceeding established best practices. The Little Rock Police Department is one of approximately 1,100 CALEA accredited agencies in over 17,985 law enforcement agencies across the country. Of those 1,100 CALEA accredited agencies, only approximately one percent have earned the Gold Standard Accreditation. The Little Rock Police Department is currently beginning the process to obtain the prestigious CALEA Tri-Arc Award for agencies that have concurrent CALEA accreditation for their law enforcement, public safety communications, and public safety training agencies.

Special Projects

Josephine Pankey NW Sub-Station

In 2016, The Little Rock Police Department in cooperation with the Josephine Pankey Community Association opened a new sub-station in the North West Field Services Division. The new sub-station will provide a base of operation for LRPD personnel in the expanding highway 10 corridor. The sub-station is a collaborative effort involving the Josephine Pankey Community Association and the little Rock Police Department in providing police and community services to this rapidly growing area.





The Pankey building houses a 3815 square feet Little Rock Police Sub-station and a 2600 square feet community center. The \$1.37 million dollar facility is on the site of the former Pankey School, which was part of the community established by educator, community developer and philanthropist Josephine Pankey in the first half of the twentieth century. The substation and community century will allow for the department to improve response times in West little Rock and the community space will serve as a meeting place for various activities.

The Public Affairs Section is responsible for disseminating accurate information to the public and media through all means and methods. The section is also responsible for coordinating with neighborhood associations and citizens on strategies to avoid criminal victimization and also acts as the contact point for the department's chaplains.

Unit Descriptions



The **Public Affairs Officer** team is responsible for the sharing of information to the public, most commonly through media relations. By putting an emphasis on media relations and transparency of information, there has been an increase of positive feedback from the media and public, in regards to overall communication and information provided.





FOIA is responsible for responding to Freedom of Information Requests from citizens, media representatives, and legal-based entities. In 2016, the unit responded to a historical high of more than 1000 requests for Little Rock Police Department; a 20 percent increase in requests from 2015.

Unit Descriptions

Neighborhood Watch Programs are an essential partnership between neighborhoods, community members and police. Cooperation between these neighborhood watch programs and the police are crucial for LRPD to accomplish our mission of protecting life and property, preserving law and order and enforcing laws. Neighborhood Watch Programs continue to increase with over 10 new Neighborhood Watch groups formed since January 2016.



Social Media is a significant element of LRPD's effort to share information with the public and keep the public informed on various law enforcement and community-oriented information. With a goal to increase community interaction, LRPD implemented various tools to improve our social media footprint. Since January 2016, LRPD increased its followers by over 288% across social media networks (Facebook, Twitter and Instagram); not including the implementation of two new social media tools (Periscope and LRPD Blog).
