OFFICERS ARRIVED AND MADE CONTACT WITH THE VICTIM, JAYLEN WALKER (B/M 02/20/2001). MR WALKER STATED THAT ON 05/01/2024 AROUND 1500 HOURS, HE WAS ROBBED AT GUN POINT BY SUSPECT#1 (LIL 9) AND #2 (D4). MR. WALKER STATED HE IS JUST NOW MAKING THE REPORT, DUE HIM BEING IN THE HOSPITAL WITH UNRELATED ISSUES.

MR. WALKER STATED THAT SUSPECT#1 AND #2 MESSAGED HIS BROTHER ON INSTAGRAM ABOUT WANTING TO GET A TATTOO COMPLETED BY HIM. MR. WALKER STATED THE TWO SUSPECTS ARRIVED AT THEIR HOUSE AND HIS BROTHER (WITNESS#1) COMPLETED THE TATTOO FOR SUSPECT#1.

MR. WALKER ADVISED EVERYONE WALKED OUTSIDE ONCE THE TATTOO WAS COMPLETED AND THEY EXPECTED TO RECEIVE THEIR PAYMENT. IT WAS AT THIS TIME, SUSPECT#1 AND #2 GRABBED THEIR FIREARMS (PISTOL/AR PISTOL) FROM THEIR VEHICLE (VEH#1) AND TOOK MR. WALKERS WALLET, AS WELL AS HIS OWN FIREARM.

LASTLY, MR. WALKER STATED HE HANDED OVER THE ITEMS THEY ASKED FOR AND THEY SUSPECTS LEFT THE AREA IN A GREY DODGE JOURNEY (DONUT ON REAR WHEEL) IN AN UNKNOWN DIRECTION.

OFFICERS WERE DISPATCHED TO THE LISTED LOCATION FOR A BURGLARY REPORT. OFFICERS ARRIVED ON SCENE AND MADE CONTACT WITH THE VICTIM, EBONY BROWN, WHO ADVISED OFFICERS OF MULTIPLE EVENTS THAT HAVE OCCURRED IN THE PAST THREE DAYS BETWEEN HER AND HER EX-BOYFRIEND, TERRENCE BETTS.

OFFICERS WERE ADVISED THAT ON 05/04/2024, AT APPROXIMATELY 1600-1700 HOURS, MS. BROWN'S CHILD, JUV1, RECEIVED A CALL FROM MR. BETTS AND MS. BROWN GOT ON THE PHONE WITH HIM. SHE ADVISED THAT HE WAS ASKING ABOUT GATHERING PROPERTY FROM HER RESIDENCE AND SHE LATER PRESUMED HIM TO HAVE BEEN CHECKING IF SHE WAS HOME BY TALKING TO HER ON THE PHONE. SHE ADVISED THAT SHE RETURNED TO HER HOME AND AS SHE WAS HEADING DOWN THE ROAD, SHE PASSED HIS VEHICLE, A DARK COLORED SEDAN, HEADING THE OPPOSITE DIRECTION.

SHE OBSERVED THE VEHICLE TO ACCELERATE, AND SHE PROCEEDED TO CATCH UP WITH IT NEAR BAPTIST HEALTH HOSPITAL, CLOSEST TO THE INTERSECTION AT EAST TWIN LAKES DRIVE AND KANIS ROAD. SHE ADVISED THAT AS SHE APPROACHED HIS VEHICLE IN HER VEHICLE, (2014 WHITE DODGE CHALLENGER NO LICENSE PLATE), HE PROCEEDED TO FIRE FOUR TO FIVE SHOTS AT HER VEHICLE. SHE LEFT THE AREA DUE TO THIS AND ONLY LATER REALIZED THAT HER VEHICLE WAS STRUCK TWO TIMES IN THE REAR.

OFFICERS WERE ADVISED THAT MS. BROWN WAS IN THE VEHICLE ALONG WITH TWO OF HER CHILDREN, JUV1 AND JUV2, AND A FAMILY MEMBER, DAVIYIA BROWN, WHEN THE SHOTS WERE FIRED. OFFICERS WERE ADVISED THAT NO OCCUPANTS WERE INJURED IN THE INCIDENT.

OFFICERS WERE ADVISED THAT WHEN SHE RETURNED HOME AFTER THIS, SHE OBSERVED HER HOME TO HAVE BEEN BROKEN INTO BY MR. BETTS AND OBSERVED DAMAGE TO HER WALLS, DAMAGE TO HER PROPERTY, AND MULTIPLE ITEMS STOLEN.

OFFICERS LOCATED TWO BULLET HOLES IN THE REAR OF MS. BROWN'S VEHICLE AND WERE ABLE TO RECOVER A SPENT BULLET FROM THE TRUNK OF THE VEHICLE. THIS WAS STORED AT THE NORTHWEST SUBSTATION PROPERTY ROOM.

OFFICERS WERE ADVISED THAT ON TODAY'S DATE, MR. BETTS RETURNED TO HER RESIDENCE AND BROKE INTO THE HOUSE AT THE SAME DOOR IN THE SAME WAY. SHE ADVISED THAT TODAY HE BROKE HER TABLE AND STOLE TWO SECURITY CAMERAS. SHE ALSO ADVISED OF A LOCK TO HER GATE THAT WAS BROKEN.

OFFICERS CONTACTED A NORTHWEST SUPERVISOR OF THIS INCIDENT AND WERE NOTIFIED THAT DETECTIVES AND CRIME SCENE WOULD NOT RESPOND DUE TO THE EVENTS OF THE TERRORISTIC ACT OCCURRING ON 05/04/2024.

OFFICERS PROVIDED MS. BROWN WITH AN INCIDENT REPORT CARD AND STRONGLY ADVISED HER TO CALL AS SOON AS AN INCIDENT OCCURS TO ALLOW OFFICERS TO GATHER EVIDENCE. OFFICERS WERE ALSO ADVISED BY HER THAT MR. BETTS HAD MADE A POLICE REPORT ABOUT HER. (2024-057060)
