NARRATIVE

POLICE RESPONDED TO 10516 TOPAZ COURT AND MADE CONTACT WITH LAJUANDA SAWYER. MS SAWYER STATED THAT SHE WAS WALKING NEAR THE LONGLEY BAPTIST CHURCH, 9900 GEYER SPRINGS ROAD, WHEN HER NEIGHBORS, DESIRAE COLBERT AND KIMBERLY NELSON, JUMPED OUT OF THE LISTED CHEVROLET COBALT ON HER. ACCORDING TO MS SAWYER, THE TWO SUSPECTS BEAT HER WITH FISTS AND A STICK THEN TOOK HER CELL PHONE. THE SUSPECTS THEN GOT BACK INTO THE VEHICLE AND LEFT THE SCENE WITH THE PHONE. POLICE OBSERVED INJURIES TO MS SAWYER'S LEFT HAND AND UPPER ARM. POLICE RESPONDED TO 10512 TOPAZ COURT AND MADE CONTACT WITH DESIRAE COLBERT WHO WAS SITTING IN THE DRIVER'S SEAT OF THE CHEVROLET COBALT. MS COLBERT WAS ADVISED SHE WAS UNDER ARREST FOR ROBBERY, HANDCUFFED, THEN PLACED IN THE BACK OF A PATROL VEHICLE. MS COLBERT STATED SHE DID NOT KNOW WHAT WAS GOING ON AND ADVISED WE COULD SEARCH HER VEHICLE. POLICE SEARCHED THE VEHICLE WITH NEGATIVE RESULTS. SOUTHWEST SUPERVISORS AND MAJOR CRIMES DETECTIVES WERE NOTIFIED OF THE INCIDENT. MS SAWYER AND MS COLBERT WERE THEN TRANSPORTED TO THE 12TH STREET SUBSTATION FOR FURTHER INVESTIGATION BY DETECTIVES, UNDER MIRANDA, MS COLBERT STATED THAT SHE AND HER MOTHER DID FIGHT MS SAWYER, BUT THEY DID NOT TAKE ANYTHING FROM HER. AFTER THE INVESTIGATION, MS COLBERT WAS RELEASED, AND MS SAWYER WAS ADVISED TO SEEK A WARRANT FOR BATTERY 3RD. MS COLBERT WAS THEN TRANSPORTED BACK TO 10512 TOPAZ COURT BY OFFICER THOMAS. MVR IN USE. OFFICER TAYLOR'S BWC BATTERY WAS DEAD AT THE TIME THIS REPORT WAS TAKEN. OFFICER THOMAS'S BWC WAS IN USE.

NARRATIVE
