NARRATIVE

OFFICERS RESPONDED TO THE LISTED AREA FOR A SHOTS FIRED CALL AT THE INTERSECTION OF HANOVER DR AND SHERATON DR.

UPON ARRIVAL, OFFICERS OBSERVED NUMEROUS PEOPLE OUTSIDE OF 36 SHERATON DRIVE AND CLOTHING STREWN ABOUT THE DRIVEWAY. OFFICERS MADE CONTACT WITH THE CALLER, MS. DONNIE SULLIVAN. MS. DONNIE ADVISED THE SITUATION WAS "HANDLED" AND WAS A DISPUTE BETWEEN TWO PARENTS THAT HAD ESCALATED. MS. DONNIE STATED ORIGINALLY HER DAUGHTER, MS. JENELLE SULLIVAN, AND THE OTHER PARENT, MS. SHAMAKIAA BOYD, WERE ATTEMPTING TO DEESCALATE A SITUATION THAT HAD BEEN ONGOING FOR MONTHS OVER THEIR TWO JUVENILE SONS. AT THAT TIME, MS JASMINE SULLIVAN, DAUGHTER OF JENELLE, AND MS SHALAJAH JOHNSON, DAUGHTER OF MS SHAMAKIAA, BEGAN TO ARGUE WHICH ESCALATED TO THE TWO "SQUARING UP" AND ATTEMPTING TO FIGHT IN THE STREET. DURING THE ALTERCATION MS. SHALAJAH GOT INTO THE LISTED VEHICLE AND SUPPOSEDLY ATTMEPTED TO RUN OVER MS JENELLE, MS JASMINE, AND JUVENILE 1 BEFORE FLEEING BACK TOWARDS THEIR RESIDENCE AT 17 HANOVER. MS DONNIE, JASMINE, AND JENELLE, ALL DENIED THERE BEING ANY SHOTS FIRED. THE LISTED VEHICLE THEN ARRIVED ON SCENE WITH THE OWNER, MS. NYSHAUNDA REED, ADVISING HER VEHICLE HAD BEEN SHOT. A FRESH BULLET HOLE WAS LOCATED ON THE DRIVERS SIDE ABOVE THE FRONT DRIVER DOOR. MS. REED STATED THAT MS. SHALAJAH HAD JUST DRIVEN THE CAR HOME AND TOLD HER THAT MS. JENELLE HAD SHOT AT HER.

OFFICERS THEN MADE CONTACT AT 17 HANOVER DRIVE WITH MS. SHALAJAH. MS. SHALAJAH STATED THAT SHE HAD GONE OVER TO 36 SHERATON WITH HER MOTHER AND THAT MS. JASMINE HAD ATTEMPTED TO FIGHT HER. SHE STATED SHE HAD GOTTEN INTO HER VEHICLE AND FLED, ADMITTING TO ALMOST HITTING SEVERAL PEOPLE, AS SHE WAS AFRAID OF BEING "JUMPED". THE ON DUTY SUPERVISOR WAS NOTIFIED OF THE INCIDENT AND RESPONDED TO THE SCENE. A NEIGHBOR WAS ABLE TO CATCH THE ALTERCATION ON CAMERA. THE SECURITY FOOTAGE, SHOWS MS JASMINE AND MS SHALAJAH AS THE TWO ATTEMPT TO FIGHT. DURING THE ALTERCATION MS SHALAJAH CAN BE OBSERVED GETTING INTO THE LISTED VEHICLE AND REPEATEDLY DRIVING FORWARD THEN BACK AND AT ONE POINT DRIVING THROUGH THE YARD AND OVER THE DRIVEWAY OF 36 SHERATON. AS MS SHALAJAH IS DRIVING AWAY, THE VIDEO SHOWS MS JENELLE PULLING OUT WHAT APPEARS TO BE A HANDGUN AND FIRING ONE SHOT AT THE FLEEING VEHICLE.

AFTER SPEAKING WITH DETECTIVES, BOTH MS SHALAJAH AND MS JENELLE WERE TRANSPORTED TO THE 12TH STREET DETECTIVES OFFICE TO GIVE STATEMENTS. AFTER SPEAKING WITH DETECTIVES, ALL PARTIES ADVISED THEY NO LONGER WISHED TO PRESS CHARGES ON ONE ANOTHER. THE REFUSAL TO PRESS CHARGES WAS A RECORDED STATEMENT TAKEN BY DETECTIVES. ALL PARTIES WERE RELEASED WITHOUT INCIDENT AND THE FAMILIES REMAINED CORDIAL.
