NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION IN REGARDS TO A ROBBERY OF A BUSINESS. UPON ARRIVAL, OFFICERS MADE CONTACT WITH BOTH VICTIMS AND THE MANAGER, GUTIERREZ.

GUTIERREZ STATED HE HAD VIDEO FOOTAGE OF THE ENTIRE INCIDENT. GUTIERREZ STATED THE UNKNOWN SUSPECT BACKED HIS VEHICLE TOWARDS NORTH RODNEY PARHAM ROAD BEHIND THE SHOPPING PLAZA SIGN. GUTIERREZ STATED THE SUSPECT WAS THE SAME PERSON FROM A PREVIOUS INCIDENT. REFERENCE 2024-032134. GUTIERREZ STATED THE UNKNOWN SUSPECT POINTED A FIREARM AT BOTH VICTIMS AND TOLD THEM TO GIVE HIM THE MONEY THAT WAS IN THE REGISTER. GUTIERREZ STATED THAT THE UNKNOWN SUSPECT DID NOT TAKE ANYTHING FROM THE BUSINESS.

NARRATIVE

OFFICERS RESPONDED TO A SHOTS FIRED AT 8800 BASELINE ROAD. OFFICERS MADE CONTACT WITH THE CALLER, NIMARLEL GAMALATH. MR. GAMALATH STATED HE HEARD SHOTS WEST OF THE LOCATION AT APPROXIMATELY 2115 HOURS.

AT APPROXIMATELY 2118 HOURS A SILVER INFINITY SEDAN DROPPED OFF ANTHONY CALDWELL AT UAMS WITH A GUNSHOT WOUND. MR. CALDWELL ADVISED HE DID NOT KNOW THE EXACT LOCATION, BUT IT WAS AT "A GAS STATION ACROSS FROM A WALMART NEAR THE HIGHWAY." MR. CALDWELL ADVISED DETECTIVES HE ALSO DID NOT KNOW THE SUSPECT AND COULDN'T DESCRIBE HIM.

OFFICERS CIRCULATED THE AREA FOR SHELL CASINGS AND BLOOD TRAILS WITH POSITIVE RESULTS AT 10101 INTERSTATE 30, THE SHELL GAS STATION. OFFICERS SET UP CRIME SCENE, OBSERVED THREE SHELL CASINGS NEAR THE SOUTH SIDE OF THE PUMPS, AND A TRAIL OF BLOOD LEADING TO THE NORTH SIDE OF THE STORE, COVERING THE DRIVERS SIDE OF A GREEN TOYOTA TACOMA (LPN: AEP21S), AND BACK TOWARDS THE GAS PUMPS NEAR THE NORTH SIDE. OFFICERS ADVISED SGT. SNOW AND MAJOR CRIMES WHO RESPONDED.

OFFICERS MADE CONTACT WITH THE CLERK, PEDRO AJCOT, WHO ADVISED HE DID NOT HEAR OR SEE ANYTHING. OFFICERS WERE ABLE TO MAKE CONTACT WITH THE STORE MANAGER, RIVEN ABDO, WHO WAS ABLE TO RESPOND AND PROVIDE SECURITY CAMERA FOOTAGE. UPON INSPECTING THE FOOTAGE, MR. ABDO STATED BOTH THE SUSPECT AND MR. CALDWELL ARE REGULAR CUSTOMERS.

THE SECURITY FOOTAGE SHOWED MR. CALDWELL AND THE SUSPECT TALKING IN THE STORE, LEAVE THE STORE TOGETHER, AND GO TO THE BACK OF THE SUSPECT'S GMC. WHEN THE TWO SUBJECTS GO BEHIND THE GMC, IT SHOWS THE SUSPECT FALLING BACKWARDS, DROP AN UNKNOWN OBJECT, GET UP RUN TO THE FRONT OF THE GMC BEFORE RETRIEVING THE UNKNOWN OBJECT, AND DRIVING OFF WESTBOUND ON BASELINE. THE FOOTAGE ALSO SHOWED MR. CALDWELL RUNNING FROM BEHIND THE GMC TOWARD THE NORTH SIDE OF THE GAS STATION WHILE LEAVING HIS LEFT SHOE AT THE PUMP NEAR THE GMC, STAYED BEHIND THE SHELL GAS STATION UNTIL THE GMC LEFT, AND THEN RAN BACK TO THE NORTH PUMPS BEFORE DRIVING OFF IN THE SILVER INFINITY SOUTH ON MABELVALE PLAZA.

OFFICERS COLLECTED THE THREE SHELL CASINGS AND THE SHOE FROM THE SCENE AND STORED THEM AT THE SOUTHWEST PROPERTY ROOM.

OFFICERS AT UAMS COLLECTED MR. CALDWELL'S CLOTHING AND PROPERTY BEFORE TRANSPORTING THEM TO CSSU.
