## NARRATIVE

OFFICERS RESPONDED TO THE DOUBLE BEE'S EXXON AT 10724 W. MARKHAM STREET IN REGARD TO A CARJACKING. OFFICERS MADE CONTACT WITH THE COMPLAINANT, MR.
