NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION FOR A SHOTS FIRED CALL. UPON ARRIVAL OFFICERS MADE CONTACT WITH VIC1(COULTER) WHO ADVISED HE WAS SHOT MULTIPLE TIMES BY AN UNKNOWN SUSPECT. COULTER ADVISED THAT AS HE PULLED UP TO THE LOCATION AND EXITED HIS VEHICLE A VAN PULLED UP BESIDE HIM AND THE SUSPECT GOT OUT AND BEGAN CHASING HIM WITH A HANDGUN AND STARTED FIRING AT HIM. COULTER ADVISED THAT HE RAN INTO "PIC PAC LIQUOR" TO TRY AND GET AWAY FROM THE SUSPECT BUT THE SUSPECT FOLLOWED HIM INSIDE BUT DID NOT SHOOT ANYMORE.

OFFICERS OBSERVED THE WOUNDS OF COULTER AND PLACED A TOURNIQUET ON HIS RIGHT ARM AND ASSISTED UNTIL MEMS ARRIVED AND TRANSPORTED HIM TO UAMS FOR HIS INJURIES. OUR BWC WAS ACTIVE ON THIS CALL.

THE SUSPECT VEHICLE WAS LOCATED IN THE NORTHWEST DIVISION BY SID DETECTIVES AND WAS TOWED TO THE CSSU BAY PENDING A SEARCH WARRANT.

NARRATIVE
