NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION IN REFERENCE TO A DISTURBANCE. UPON ARRIVAL, OFFICERS MADE CONTACT WITH THE STAFF OF THE BUSINESS, MS. HERNANDEZ, MS. IVERSON, AND MS. MERRITTON. ALL PARTIES ADVISED THEY OBSERVED MS. HOLMES ENTERED THE PLACE OF BUSINESS. ALL PARTIES ADVISED THEY RECOGNIZE MS. HOLMES FROM PREVIOUS THEFT INCIDENT. ALL PARTIES ADVISED THEY WAITED FOR MS. HOLMES AT THE FRONT ENTRANCE BECAUSE THEY KNEW SHE HAD SOME STOLEN ITEMS. ALL PARTIES ADVISED THEY CONFRONTED MS. HOLMES, ALL PARTIES ADVISED WHEN THEY CONFRONTED MS. HOLMES SHE GOT UPSET, ALL PARTIES ADVISED WHEN THEY ATTEMPTED TO RETRIEVE THE STOLEN ITEMS MS. HOLMES PUSHED ALL THREE EMPLOYEES OF THE BUSINESS AND GOT INTO A PHYSICAL ALTERCATION. ALL PARTIES ADVISED THEY WERE ABLE TO TAKE MS. HOLMES BLUE PURSE THAT CONTAINED THE STOLEN PROPERTY WHICH WAS RECOVERED, OFFICERS WERE GIVEN ACCESS TO SURVEILLANCE FOOTAGE OF THE INCIDENT BY MS. HERNANDEZ. OFFICERS WERE ABLE TO LOCATE MS. HOLMES ON THE O'REILLY AUTO PART STORE AT THE SAME LOCATION, WHEN OFFICERS MADE CONTACT WITH MS. HOMES SHE STATED, "I KNOW I WAS IN THE WRONG FOR SHOPLIFTING, BUT THEY ATTACKED ME, AND I DEFENDED MYSELF". OFFICERS TOOK MS. HOLMES INTO CUSTODY. OFFICERS NOTIFIED A SUPERVISOR AND A DETECTIVE AND WERE MADE AWARE OF THE SITUATION. ALL PARTIES INVOLVED FILED OUT A LRPD WITNESS STATEMENT, (LRPD FORM 5400-11). MS. MERRITTON WAS PROVIDED WITH A REPORT NUMBER, MS. HOLMES ADVISED SHE HAD \$800 TO \$1000 DOLLARS STOLEN OUT OF HER PURSE AND CLAIMED THE STAFF OF THE BUSINESS STOLE HER MONEY.
