

Ward 3 - 2013 to 2015 Bond/Sales Tax Summary

- A total of \$2,600,000 in Sales Tax funding was allocated.
- A total of \$7,700,000 in Bond Issues was allocated.
- In the 2013 to 2015 project request list, there were 94 jobs requested.
- A total of 9 Bond Program jobs and 8 Sales Tax Program jobs were selected and are in the process of design, bidding, and construction.
- Currently 11 jobs (65%) are in design, 5 jobs (29%) are currently in construction, and 1 job (6%) is totally complete.
