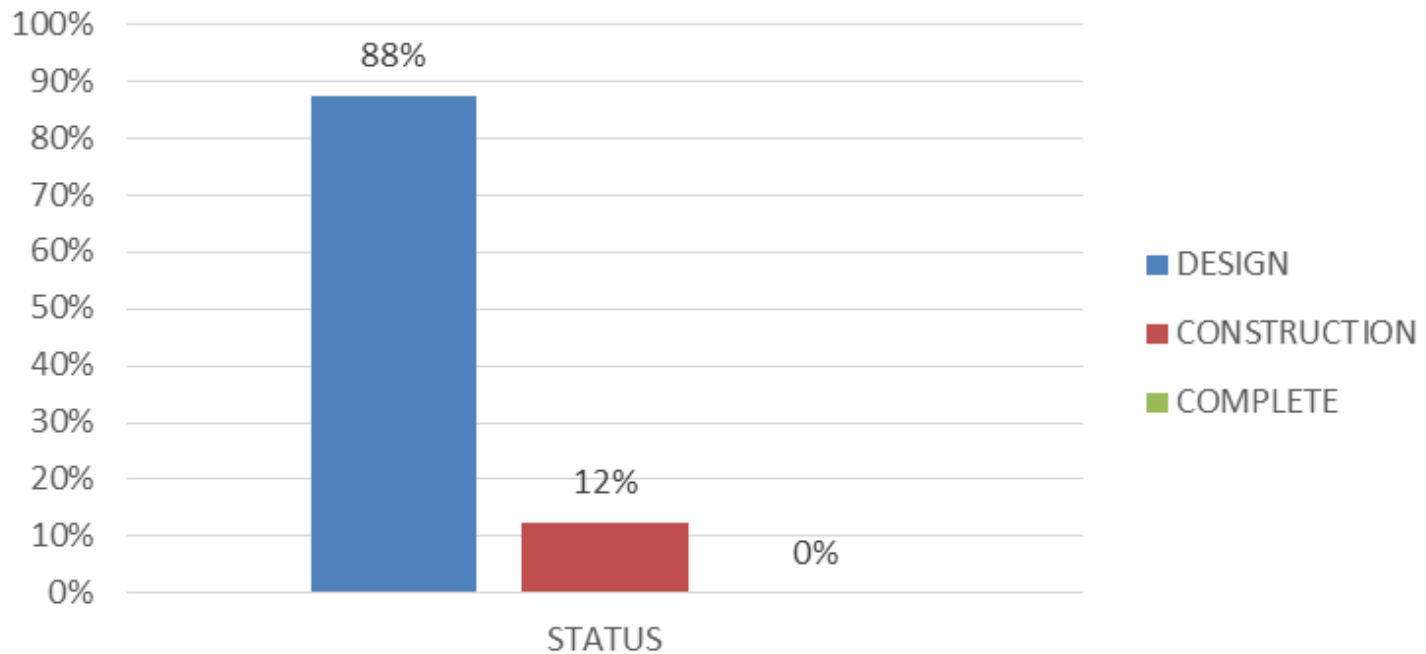
Ward 6 - 2013 to 2015 Bond/Sales Tax Summary

- A total of \$2,600,000 in Sales Tax funding was allocated.
- A total of \$7,000,000 in Bond Issues was allocated.
- In the 2013 to 2015 project request list, there were 22 jobs requested.
- A total of 4 Bond Program jobs and 4 Sales Tax Program jobs were selected and are in the process of design, bidding, and construction.
- Currently 7 jobs (88%) are in design, 1 job (10%) is currently in construction, and 0 jobs (0%) are totally complete.
