## STAFF REPORTS -

City lien foreclosure report- 1021 S. Woodrow has commissioners deed 4/19/11. 2318 Wright avenue lien has been contested.

*Property Inventory*- Forty-nine properties have been attained. 2209 W. 10<sup>th</sup> and 2520 W. 13<sup>th</sup> transferred to Habitat for Humanity for development. An application for 1805 Wolfe St. was submitted as a donation.

NSP2- City of Little Rock has demolished and is in the process of demolishing twenty-eight properties under the NSP2 program. The City of Little Rock has closed on 1916 Booker St. last Friday. The City of Little Rock will be closing on 1900 Johnson, 1825 Dennison, 2414 W. 13<sup>th</sup>, 3411 W. 10<sup>th</sup>, 3103 W. 13<sup>th</sup>, 3105 W. 13<sup>th</sup>, 3107 W. 13<sup>th</sup>, 3419 W. 10<sup>th</sup>, 811 Martin, and 901 Booker.

Park and it was moved by Commissioner Chan and second by Commissioner Schild. Motion carried.
