)	which is the base bid amount of One Hundred Ten Thousand, Four Hundred Thirty-Three and 60/100
)	Dollars (\$110,433.60), plus 20% contingencies.
1	Section 2. Funding for this project is from the 3/8-Cent Capital Improvement Sales and Compensating
2	Use Tax Funds as authorized by Resolution No. 14,310.
3	Section 3. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, or
4	word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or
5	adjudication shall not affect the remaining portions of the resolution which shall remain in full force and
5	effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the
